Subject : Report

Sir,

I have the honour to report that today i.e. the 31st March, 2025 at about 2:00 p.m. received a reliable information about the presence of some active members of the outlawed outfit KCP at Sawombung Imphal East District. Based on the said information, teams of CDO/IE Unit assisted by SI. Kh. Victor Singh of CDO/IE Unit, ASI. S. Suraj Singh of CDO/IE Unit and Hav. No. 05006254 Th. Gyanizail Singh of 1st MR/CDO/IE under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted C. I. Ops. at the said area at about 2:40 p.m.

As part of the searched operation, random frisking and checking was conducted to the suspected passersby at Sawombung Thongkhong. In that, two scooters coming from southern side were warned to stop for checking and verification. The two scooters, instead of paying heed to the warning to stop for verification, they tried to run away from the hands of our CDO teams. In that, our CDO teams managed to stop one scooter and the second

scooter fled away from the frisking and checking point. Immediately, one of our team followed the escaping scooter.



On checking the pillion rider of the detained scooter (Honda Activa), one 9 mm Pistol loaded with 3 (three) live rounds in the magazine, one pistol holster, one mobile phone were found and recovered from his possession. From the possession of the driver, one mobile phone was found and recovered. On verification, the driver identified himself as one Khoinaijam Robertson Singh (24 years) S/o (Late) Kh. Tolen Singh of Chingmeirong Maning Leikai, Imphal West, A/p - Sawombung Thongkhong, Imphal East and the pillion rider identified himself as one Khoisnam Sanajaoba Singh @ Sindamba (27 years) S/o Kh. Gandhi Singh of Khurai Ningthoubung Leikai, Porompat PS, Imphal East District. On further verification, the detainee, Kh. Sanajaoba Singh, stated that he joined the outfit through one Mr. Ranson @ Tayei of KCP (NOYON/MFL) in the year 2015 and got his basic military training in the same year at Leipok, Myanmar for 45 days under the command of one Mrs. Melody and one Mr. Lamngakpa of KCP (Noyon) and presently working under the command of one Mr. Amuba @ Chaklamba of KCP (NOYON/MFL). He (Kh. Sanajoba Singh) further stated that the above recovered 9 mm pistol was handed over to him by one Yumkhaibam Ronaldo Singh of KCP (NOYON/MFL) from Khurai Ningthoubung, Imphal East about five days before.

On further verification of the driver of the scooter (Kh. Robertson Singh) he stated that he joined the outfit through the first detainee, pillion rider - Kh. Sanjaoba Singh, and presently working under his (Kh. Sanajaoba Singh) command.

So, both the detainees were arrested from the spot i.e. Sawombung Thonkhong at 3.21 p.m. by observing due formalities. From the possession of the arrestee, Kh. Sanajaoba Singh; (i) One 9 mm Pistol marked as 'ITALY MADE No. 9 mm' loaded with three live rounds in the magazine, (ii) one pistol holster, (iii) one mobile phone (Redmi 12 5G) bearing IMEI no. 864985064713701 & 864985064713719 along with one Jio SIM Card bearing no. 89918650400115493019 were seized at 3:30 p.m. From the possession of the arrestee, Kh. Robertson Singh, one mobile phone (Redmi 4A) bearing IMEI no. 866590035101321 & 866590035101339 along with one Airtel SIM card bearing no. 8991160990024265789U and one scooter (Honda Activa), red in colour, bearing regd. no. MN-01R/8824 bearing Engine no. JC44E0015625 and Chassis no. ME4JC445C98813188 were seized from his possession by observing due formalities at 3:35 p.m.

In the meantime, our CDO team which followed the escaping scooter, managed to put the escaping person under their control at Itam Nungoi near Ibudhou Wangbren Laishang, Imphal East. On checking the detainee body, one mobile phone was found and recovered. On verification, the detainee identified himself as one Soubam Rohit Singh (23 years) S/o S. Ajit Singh of Saoibam Leikal, Ayangpalli Road, Imphal East District. He further stated that he is an active member of the outfit KCP (NOYON/MFL) and presently working under the command of the above arrestee, Kh. Sanajaoba Singh. So, the detainee, Soubam Rohit Singh was arrested at the spot i.e. Itam Nungoi near Ibudhou Wangbren Laishang, Imphal East at 3:50 p.m. From the possession of the arrestee S. Rohit Singh, seized one scooter (Hero Pleasure), orange and white in colour, bearing regd. no. MN-01U/2308 bearing Engine



no. JF16ECEGJ06048 & Chassis no. MBLJF16EJEGJ03035 and one mobile phone (Redmi 13 5G) IMEI no. 864328078493061 & 864328078493079 along with one Airtel SIM Card bearing no. 8991160990023769037U at 3:55 p.m.

From the disclosures of the above arrestee, Kh. Sanajaoba Singh, it came to learnt that one of his associates was waiting for him at Langol, Imphal West. Immediately, our team along with the arrestees rushed to Langol, Imphal West after providing prior information of Imphal West District Police. On reaching Langol Zone IV, as identified by the arrestee, Kh. Sanajaoba Singh, arrested one Leishangthem Naobi Singh @ Yohenba (33 years) S/o L. Inaotombi Singh of Langol Game Village, Zone - II, Imphal West from the spot i.e. Langol Zone - IV, crossing Imphal West at 6:49 p.m. by observing due formalities. The arrestee, Leishangthem Naobi Singh, stated that he is an active member of the outfit (NOYON/MFL) presently working under the command of the said Mr. Amuba of KCP (NOYON/MFL) group.

On further examination of the arrestee, Kh. Sanajaoba Singh, it further came to light that another one of his associates is also waiting for him at Lamlai Mayai Leikai, Imphal East. Immediately, our team along with the arrestee rushed to Lamlai Mayai Leikai, Imphal East. Based on the arrestee's (Kh. Sanajaoba Singh) instance and identification, arrested one Khaidem Nongpoknganba Meitei 25 S/o Kh. joychandra Singh of Lamlai Mayai Leikai, Imphal East District from Lamlai Mayai Leikai, near Lamlai Community Hall at 8:24 p.m. by observing due formalities.

Therefore, the arrested persons along with the seized arms, ammunitions, scooters and mobile phones are being handed over to you for taking up further necessary legal actions against them.
