Sir.

I have the honour to report that today i.e. the 2nd April, 2025 at about 1:00 p.m. received a reliable information about the presence of some active members of the outlaw outfit RPF/PLA at Sanjenbam village of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops at the said area at about 1:30 p.m.

As part of the searched operation random frisking and checking was conducted to suspected passersby. In that, one unknown suspected person was detained for checking and verification at Sajenbam Khunou near Waiting Shed. On checking his body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one Thounaojam Sachindra Singh @ Laba @ Alex (24 years) S/o Th. Sunil Singh of Takhel Mamang Leikai, Lamlai PS, Imiphal East. On further verification, the detainee stated that he joined the said outlawed outfit through one Mr. Langon of RPF/PLA in the month of November, 2024 and presently working under the command of one Mr. Ingba of RPF/PLA.

So, the detainee was arrested from the spot i.e. Sanjenbam Khunou near Waiting Shed, Imphal East District at 2:10 p.m. by observing due formalities. One mobile phone (Redmi), blue in colour was seized from his possession at the spot i.e. Sanjenbam Khunou near Waiting Shed, Imphal East at 2:15 p.m.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
