Sir,

I have the honour to report that today i.e. the 3<sup>rd</sup> April, 2025 at about 4:00 a.m. received a reliable information about the presence of some active members of the outlawed outfit RPF/PLA at Chingarel Tejpur, Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a cordon and search operation at the said area at about 5:00 a.m.

In that, one suspected person was detained for verification at Chingarel Tejpur Mayai Leikai, Imphal East District. On verification, the detainee identified himself as one Yendrenbam Athoiba Meitei @ Leingakpa (24 years) S/o (Late) Y. Inaoton Meitei of Chingarel Tejpur Mayai Leikai, Imphal East. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA. He further stated that he joined the said outfit RPF/PLA in the month of February, 2024 and presently working under the command of one Mr. Irengba of RPF/PLA. The detainee further stated that he is directly involved in recruiting of new cadres to their outfit on the instruction and guidance of the said Mr. Irengba of RPF/PLA.

So, the detainee was arrested from his residence i.c. Chingarel Tejpur Mayai Leikai, Imphal East at 5:31 a.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
