I have the honour to report that today i.e. the 3rd April, 2025 at about 4:00 a.m. received a reliable information about the presence of some active members of the outlawed outfit KCP at Phaknung area of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 5:00 a.m.

As a part of the operation, some suspected houses were cordoned and searched was conducted. In that, one suspected person was detained for verification. On verification, the detainee identified himself as one Okram Herojit Singh (31 years) S/o (Late) O. Thoiba Singh of Phaknung Sangomshang Litan Makhong, Imphal East District.

On further verification, the detainee stated that he is an active member of the outfit KCP (City Meitei) group joined through one Mr. Jebraj of KCP (City Meitei) in the month of May, 2024 and got his basic military training under the command of one Mr. Nongpok of KCP (City Meitei). The detainee further stated that he is presently working under the command of one Mr. Premjit @ Papa of KCP (City Meitei).

So, the detainee was arrested from his residence i.e. Phaknung Sangomshang Litan Makhong, Imphal East District at 5:37 a.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
