On further verification, it is found that these individuals with other persons are involved in inducement of hiring/ recruiting women for the purpose of committing sexual exploitation.

Hence, a suo motto case is registered against the three above mentioned accused persons which is punishable u/s 143(2)/3(5) BNS.


