Sir,

I have the honour to report that today i.e. the 13th February, 2025 at about 9:00 a.m. received an information from a reliable source about the presence of some anti-social elements are loitering in and around Khurai-Lamlong Bazar, Imphal East District with an intent to conduct pre-judicial activities like extortion of money from the general public. Based on the said information, teams of CDO Imphal East Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a random frisking and checking to the suspected passersby at Khurai Thoudam Leikai, near Crematorium, Imphal East District.

In that, one suspected person coming in a scooter (Honda Dio), red and black in colour, was stopped for checking and verification. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one **Leimapokpam Sanjit Meitei @ Naobi (54 years) S/o (Late) L. Gunamani Meitei of Khurai Thangjam Leikai, Porompat PS, Imphal East** an active member of the outfit KCP (Noyon) group.

On further verification, the detainee stated that he joined the said organisation through one s/s – Publicity Secy. Mr. Panthoi of KCP (Noyon). The detainee further stated that, on the advice of the s/s – Publicity, he had extorted a huge amount of money from general public, govt. officials, hospitals, govt. Schools, petrol pump etc. for raising their party fund. The detainee further stated that today on the advice of the said s/s – Publicity Secy. Mr. Panthoi of KCP (Noyon), he is on his way to collect extortion money from various shops/shopkeepers located at Khurai Lamlong Bazar, Imphal East.

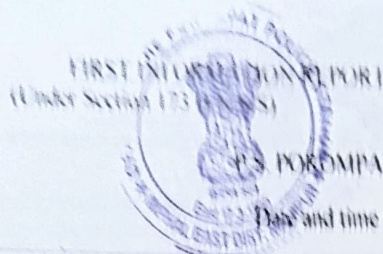
In the above facts and circumstances, the detainee was arrested from the spot i.e. Khurai Thoudam Leikai, near Crematorium, Imphal East District at 10:28 a.m. by observing all formalities and seized; (i) **one scooter (Honda Dio), red and black in colour) without regd. no., bearing Engine no. JF11E4117707** and (ii) **one mobile phone (NOKIA- TA-1416) bearing IMEI no. 356980591231934/1 & 356980594231931/1 along with one Airtel SIM Card No. 8991160990008495400U** from his possession at 10:38 a.m. from the spot i.e. Khurai Thoudam Leikai, near Crematorium, Imphal East District by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
