Sir,

I have the honour to report today i.e. the 18th February, 2025 at about 3:00 p.m. received a reliable information about the presence of some extortionists at Hatta-Golapati, Imphal-East. Based on the said information, teams of CDO/IE Unit led by myself under the command of Inspt. Kh. Henery Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a random frisking and checking to the suspected passersby at Hatta near Public Hospital, Imphal East.

In that one suspected person coming in a scooter from northern side towards our frisking and checking point was detained for spot verification. On verification the detainee identified himself as one Waikhom Ibungo Meitei @ Mangal, aged about 26 years, S/o W. Tomba Meitei of Yairipok Leirongthel Makha Leikai, Yairipok PS, Thoubal District District, an active member of the outlaw outfit RPF/PLA. On further verification, the detainee stated that he joined the said outlaw organisation through one Mr. Melei of RPF/PLA in month of September, 2024 and presently working under his command. The arrestee stated the he was involved in extortion of money and recently on the advice of the Mr. Melei of RPF/PLA, he had extorted a huge amount of money from general public, govt. Officials, Schools and colleges etc. for raising their party fund.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Hatta near Public Hospital, Imphal East at 3:38 p.m. by observing all formalities and seized; (i) one scooter (Hero Maestro), blue in colour, with regd. no. MN-06SD/5387 bearing Engine no. JF17ELLGK12698 & Chassis no. MBIJFW204LGK03441, (ii) one mobile phone (Realmi 8) bearing IMEI no. 863265054773051/18 & 863265054773044/18 along with one Aritel SIM card bearing no. 8991160990007527224U and (iii) one mobile phone (Oister OT310) bearing IMEI no. 354486212859154 & 354486212859162 along with one Aritel SIM card bearing no. 8991160990026976451U at the spot i.e. Hatta near Public Hospital, Imphal East at 3:45 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
