I have the honour to report that today i.e. 04/03/2025, at about 5:00 a.m. a reliable input was received about presence of some extortionists member of outlawed outfit RPF/PLA in and around Sagolmang area. Based on the said information, teams of CDO Imphal East Unit led by myself under the command of Inspt. Kh. Henery Singh, Officer-in-Charge Commando Imphal-East Unit and under the supervision of Shri. Kh. Herojit Singh, MPS, Addl. SP(Ops) Imphal East District rushed to the said area and conducted a searched operation. In that, one suspected unknown person was detained for spot verification.

On verification, the first detainee identified himself as one Laishram Bijoy Singh (56 years) S/o (Late) L. Manglem Singh of Sagolmang Khewa, Sagolmang PS, Imphal East District, Manipur. On further verification, the detainee stated that he is an active member of the outlaw outfit RPF/PLA group joined through one s/s – Deputy Finance Mr. Jibon of RPF/PLA and presently working under his command. The detainee further stated that on the advice of the said Mr. Jibon of RPF/PLA, he had handed over one mobile phone handset to one of his associate namely, Ngairangbam Ajit Singh of Yourabung about half a month before for communicating with the said s/s – Deputy Finance Mr. Jibon of RPF/PLA. So, the detainee was arrested from the spot i.e. Sagolmang Khewa, near CHC (Community Health Centre), Sagolmang, Imphal East at about 6:20 a.m.

On further verification, it came to light that his associate (Ngairangbam Ajit Singh) which he mentioned above is presently residing at his residence at Yourabung. Immediately, our team along with the arrestee rushed to Yourabung and on the pointing of the arrestee (Laishram Bijoy Singh) arrested one Ngairangbam Ajit Singh (59 years) S/o (Late) Ng. Ibocha Singh of Yourabung Mayai Leikai, Lamlai PS, Imphal East District, Manipur from Yourabung Mayai Leikai, Imphal East near Waiting Shed at 7:15 a.m. and seized one mobile phone (Redmi A3X) bearing IMEI no. 866024076296246 & 866024076296253 along with one Airtel SIM card bearing no. 8991160990023679905U from his possession at 7:20 a.m.

On verification of the second arrestee, Ngairangbam Ajit Singh, he stated that he is an active member of the outfit RPF/PLA, joined the outfit RPF/PLA in month of October, 2024 through the said s/s – Deputy Finance Mr. Jibon of RPF/PLA and presently working under his command. The arrestee further stated that, recently on the advice of the said Mr. Jibon of RPF/PLA he made a monetary demand to a construction company for raising their party fund. Both, the arrestees stated that they were involved in extortion of money from general public, private firms, govt. Officials etc.

In both places of making arrest of the above persons, our CDO teams were obstructed in performing the lawful duties and due to this reason, the mandatory provision of photography and videography while making arrest and seizure of the above persons could not be done.

The arrested persons along with the seized mobile phone are being handed over to you for taking up further necessary legal procedures against them.
