Sir,

I have the honour to report today i.e. the 14th February, 2025 at about 3:30 p.m. received an information from a reliable source about the presence of some armed extortionists belonging to the outfit UNLF at Nungoi area of Imphal-East District. Based on the said information, teams of CDO/IE Unit led by myself under the command of Inspt. Kh. Henery Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a Counter Insurgency Operation at the said area.

As a part of the C.I.Ops., random frisking and checking was conducted to the suspected passersby at Nungoi Awang Leikai, Imphal East District. During that, one suspected person was spotted coming from western side towards our frisking and checking point. The unknown suspected person seems to be uneasy and perturbed on seeing our CDO personnel and walk very hurriedly as if he was trying to escape from the eyes of our CDO personnel. On the suspicious manner of the unknown person, our CDO personnel immediately, warned the man to halt for spot verification and checking. To it, the unknown suspicious man instead of paying heed to the warning he tried to make a good way off. Immediately, our CDO personnel chased the escaping unknown person and overpowered within minutes and put under our control.

On checking the detainee body, one .32 Pistol loaded with three live rounds in the magazine was found and recovered from the right waist line of his body. One mobile phone was also found and recovered from the left front pant pocket. On verification, the detainee identified himself as one Okram Aboy Meitei (37 yrs) S/o O. Shyam Meitei of Nungoi Awang Leikai, Lamlai PS, Imphal East District, an active member of the outlaw outfit UNLF (Pambei) group. On further verification, the detainee stated that he joined the said outlaw organisation though one s/s – Sergeant Mr. Naoton from Nungoi of UNLF (Pambei) group in the month of April, 2023 and presently working under the command of one s/s – Corporal Mr. Hemanta @ Lakpa from Uyumpok of UNLF (Pambei) group. The detainee further stated that the above recovered pistol was handed over to him by one Mr. Sharat about two month before.

So, in the above facts and circumstances, the he detained was arrested from the spot i.e. from Nungoi Awang Leikai, near Tera Makhong, Lamlai PS, Imphal East District at 4:19 p.m. by observing due formalities. From his possession, one .32 Pistol marked as 'MADE IN USA' loaded with three live rounds in the magazine and one mobile phone (POCO C51) bearing IMEI no. 864519068726706 & 864519068726714 along with two SIM cards bearing no. Jio 8991865400013408002 and Airtel -8991160990020022810U were seized from his possession at the spot i.e. Nungoi Awang Leikai, near Tera Makhong, Lamlai PS, Imphal-East District by observing due formalities at 4:30 p.m.

Therefore, the arrested person along with the seized arms, ammunitions and mobile phone is being been handed over to you for taking up further legal procedures against him.
