Sub- Report.

I have the honour to report that today i.e. 15<sup>th</sup> February, 2025 at about 6:00 a.m. received an information from a reliable source about presence of some armed members/cadres of the outlawed outfit KCP at Andro, Imphal East District with an intent to commit prejudicial activities like extortion, kidnap etc.. Acting on the said input, a combined force of CDO Imphal East Unit along with woman police personnel led by myself and a column of O.P.G.R. under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the supervision of Sub. Insp. Herojit Singh, MPS Addl. SP(Ops)IE conducted a cordon and search operation at Andro Khanou, Imphal East District at 7:00 a.m.

In that, four persons i.e. two men and two women, were detained for verification and checking. On verification, the detainees identified themselves as; (i) Chaphamayum Sunder Singh @ Suresh (39 years) S/o Ch. Chalgot Singh of Pukhao Naharup Makha Leikai, Sagolmang PS, Imphal East, (ii) Nongthombam Boinao Meitei @ Lanjadaba (48 years) S/o (Late) N. Ibohanbi Meitei of Churachandpur Khumujamba Leikai, Churachandpur PS, Churachandpur District, (iii) Leichonbam Abesana Devi @ Pangthungnganbi (26 years) W/o (Late) L. Barister Singh of Singda Kadangban Part -I, Lamshang PS, Imphal West and (iv) Maibam Tony Chanu @ Chingkhelinganbi (23 years) D/o - (Late) M. Inaobi Meitei of Wangjing Wangkhei Maibam Leikai, Wangjing PS, Thoubal District.

On checking the body and belongings Chaphamayum Sunder Singh, one 9 mm pistol loaded with five live rounds in the magazine, one mobile phone and some incriminating documents and booklets were found and recovered from the possession of Chaphamayum Sunder Singh. One 9 mm Pistol with magazine, 5 (five) nos. of 9 mm ammunitions, 1 (one) .32 calibre ammunition and two nos. mobile phones were found and recovered from the possession of Nongthombam Boinao Meitei. One mobile phone and one AADHAR card were found and recovered from the possession Leichonbam Abesana Devi when checked by woman police personnel. Two nos. of mobile phones, one sling bag and one AADHAR card were found and recovered from the possession of Maibam Tony Chanu when checked by woman police personnel.

On further verification, the detainees stated that they are active members of the outfit KCP PWG group and presently working under the command of one Mr. Khaba of KCP (PWG) group. They further stated that they were indulged in extortion of money from the general

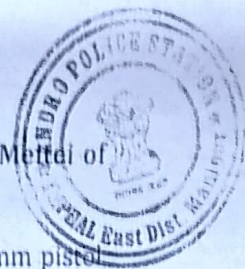

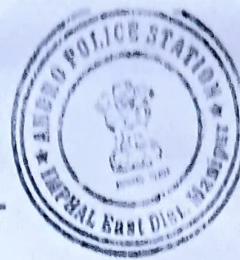
