Subject: Report.

Sir,

I have the honour to report that yesterday i.e. the 5th February, 2025 at about 9:20 pm, an information was received that two non-locals who had been abducted by some unknown persons for ransom were keeping in confinement somewhere in Kairang-Heingan Khong area. Accordingly, a combined team of CDO Imphal East and Heingang PS under the command of Inspt. Kh. Henery Singh, OC-CDO/IE and Inspt. Kh. Pathou Meitei OC-HNG/PS under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a search and rescue (SAR) operation in the said area.

In that, three suspected persons were detained and verified at Heingangkhong, near Hundred Flower School, Imphal East District. On verification, they identified themselves as; **Md. Anwar Hussain (40 years) S/o – (Late) Md. Nazir Hussain of Yairipok Ningthounai Makha Leikai, Yairipok, A/p – Hatta near Petrol pump, Imphal-East District, (ii) Rintu Mina (37 years) S/o Nur Bakta Sheikh of Kanaimara Part-II, South Salmara PS, Dhubri District, Assam and (iii) Montu Sheikh (20 years) S/o – Akbar Ali of Gasbari Village, Mankachar PS, Dhubri District, Assam.** On checking the detainees; one mobile phone and one wallet containing one AADHAR card were recovered from the possession of the detainee Md. Anwar Hussain.

One mobile phone each were recovered from the possession of the detainees Rintu Mina and Montu Sheikh. On verification of the detainees, Md. Anwar Hussain, he stated that he along with his associates namely, Md. Athoibi from Khumidok Arapti, Md. Zakir from Lilong Tolenkhun, Part-I Thoubal District and Md. Yahiya Khan @ Nurul S/o – Md. Nahatomba from Thoubal Moijing Wangmataba A/p – Khabeisoi near 7th MR Gate, a Police Constable presently posted at Bishnupur District Police, had kidnapped the above two detainees (Rintu Mina and Montu Sheikh) and made a ransom of Rs. 5, 00, 000/- (five lakh rupees). He (Md. Anwar) further stated that, so far they had collected/received a total sum of Rs. 1, 20, 000/- (one lakh twenty thousand rupees) as ransom through online transaction (PhonePe App) having account/mobile no. +91 7085382810 (mislahur@ybl) under the name of Islahur Rahaman.

On verification of the detainees (Rintu Mina and Montu Sheikh), they stated that they were kidnapped by the said Md. Anwar Hussain and his associates and made a monetary demand of Rs. Rs. 5, 00, 000/- (five lakh rupees) to safely released them from their custody.

So, in the above facts and circumstances the detainee Md. Anwar Hussain (40 years) S/o – (Late) Md. Nazir Hussain of Yairipok Ningthounai Makha Leikai, Yairipok, A/p – Hatta near Petrol pump, Imphal-East District was arrested from the spot i.e. Heingangkhong near Hundred Flower School at 11:35 p.m. One mobile phone (NOKIA - TA-1203) bearing IMEI no. 3576961073606624 Airtel SIM card no. 899100020809930135U and one wallet containing one AADHAR Card were seized from his possession at 11:45 p.m. from the spot i.e. Heingangkhong near Hundred Flower School by observing due formalities.

Further, the victims (Rintu Mina and Montu Sheikh) stated that, they were tortured, shifted from place to place and threaten to kill by the said Md. Anwar Hussain and his associates since they had been kidnapped if their (Rintu Mina and Montu Sheikh) family fail to fulfil their monetary demand.

Further searched operation are being conducted to apprehend the said, Md. Athoibi of Khumidok Arapti, Md. Zakir of Lilong Tolenkhun and Md. Yahiya Khan @ Nurul of Thoubal, A/p – Khabeisoi. But still they are at large.

Therefore, the above mentioned rescued persons namely; Rintu Mina (37 years) S/o Nur Bakta Sheikh of Kanaimara Part-II, South Salmara PS, Dhubri District, Assam and Montu Sheikh (20 years) S/o – Juma Khan and Md. Anwar Hussain (40 years) S/o – (Late) Md. Nazir Hussain of Yairipok Ningthounai Makha Leikai, Yairipok, A/p – Hatta near Petrol pump, Imphal-East District along with the seized items are being handed over to you for further legal procedures.
