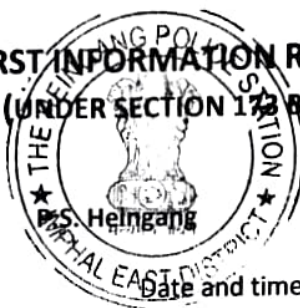

Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/02/2025 at about 04:20 pm, received a reliable information from sources about the presence of some active cadres of G-5 organisation in and around Luwangsangbam, Koirengai area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri. P. Achouba Meetei, MPS, Dy.SP (CDO)IW and Inspector Kh. Pathou Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Luwangsangbam area. During that one unknown person was seen standing near one Honda Activa Scooter at Luwangsangbam near Liberal College Gate in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Moirangthem Alexgender Singh (22 yrs) @ Satpa S/o. M. Amuba Singh of Nongpok Sanjenbam Khullen Leikai, Imphal East District. On spot checking, the following articles were recovered from his possession: one POCO X4 Pro 5G mobile handset along with two SIM cards i.e. (a) one Jio SIM card bearing mobile number 6009315425 (as disclosed by him) and (b) one Airtel SIM card bearing mobile number 8131976317 (as disclosed by him).

During preliminary verification, he disclosed that he is an active cadre of G-5 organisation (who belongs to PREPAK organisation) and joined the said organisation in October, 2023 through one Malo from Nongpok Sanjenbam Khunou Leikai and he got Basic Military Training for 3 months at Pourabi, Lamalai, Imphal East District in the year 2023 and presently working under the command of one s/s Commander Ibomcha (Ph. No. 7005397592) of G-5 organisation (who also belongs to PREPAK organisation) and under the instruction of his commander he served monetary demands from the general public, shops and government etc. since the year 2024 and he had collected around Rs. 10,000/- from Phumlou Rice Agent and Rs. 20,000/- from Lamsang shopkeeper and he handed over the extorted money to his commander for their party fund by using a Honda Activa Scooter H-Smart blue in colour without registration number. Further, he disclosed that he also collected a sum of Rs. 10,000/- from the loaded trucks and vehicles plying NH-2 and handed over the same to one Thoujal of G-5 organisation (who also belongs to PREPAK organisation).

Hence, he was arrested at the spot at 05:08 pm and the above recovered articles along with one Honda Activa Scooter H-Smart blue in colour without registration number and its key were seized at 05:13 pm by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against him.
