Sir,

I have the honour to report that today i.e. 14th February, 2025 at about 9:00 a.m. received an information from a reliable source about the presence of some active members of the outfit KCP at Khabeisoi, Imphal East District with an intent to commit prejudicial activities like extortion of money from the general public. Acting on the said input, teams of CDO Imphal East Unit led by myself under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE conducted a C.I. Ops at the said area:

In that, three persons, two pedestrian and one person came in a scooter were detained for verification and spot checking at Khabeisoi 7 MR Gate near Auto-rickshaw parking, Imphal East. On verification, the driver of the scooter, identified himself as one; **Lanpoklakpam Sanathoi Meitei @ Kaoba (23 years) S/o L. Apik Meitei of Kumbi Setapur Maning Leikai, Kumbi PS, Bishnupur District, A/p - Khabeisoi near 7 MR Gate, Imphal East.** On checking, one mobile phone was found and recovered from his possession. On further verification, the detainee (Sanathoi) stated that he is an active member of the outfit KCP (PWG) who joined through one Mr. Naocha of KCP (PWG) from Mayang Imphal in the month of April, 2023 and presently working under his command.

On verification, of the two pedestrian, they identified themselves as; **Sanabam Amitkumar Singh (40 years) S/o (Late) S. Ibochou Singh of Torbung Bangla, Moirang PS, Bishnupur District, A/p - Khabeisoi 7 MR Gate, Imphal East and Seram Prem Singh @ Bemsingh (49 years) S/o (Late) S. Bijoy Singh of Haorang Keirel Mayai Leikai, Lamshang PS, Imphal West.** On checking, one mobile phone each and one wallet each were found and recovered from their possessions. On further verification, both the detainee stated that they active members of the outfit KCP (PWG) joined in the month of May, 2023 through one s/s - Major Mr. Lancha of KCP (PWG) group and presently working under his command.

So, all the three detainees were arrested from the spot i.e. Khabeisoi 7 MR Gate near Auto-rickshaw parking, Imphal East at 11:40 a.m. by observing due formalities.

One scooter, (Suzuki Swish), red and black in colour bearing regd. no. MN-01V/4108 and one mobile phone (VIVO Y28) bearing IMEI no. 866335077081340 & 866335077081357 along with one Airtel Sim Card bearing no. 8991160990026757783U were seized from the possession of the arrestee, L. Sanathoi Singh, by observing due formalities at 11:50 a.m. from the spot i.e. Khabeisoi 7 MR Gate near Auto-rickshaw parking, Imphal East.

From the possession of the arrestee, S. Amitkumar, one mobile phone (POCO C50) bearing IMEI no. 868492063480248 & 868492063480255 along with one Jio SIM Card bearing no. 8991865040012852945 and one wallet containing a sum of Rs. 20/- (twenty rupees) and one AADHAR card were seized at the spot i.e. Khabeisoi 7 MR Gate near Auto-rickshaw parking, Imphal East at 12:00 noon by observing all formalities.

One mobile phone, (Redmi 9A) bearing IMEI no. 863537053959265 & 863537053959257 along with one Airtel SIM card bearing no. 8991000922101036348U and one wallet containing one AADHAR card were seized from the possession of the arrestee S. Prem Singh at 12:10 p.m from the spot i.e. Khabeisoi 7 MR Gate near Auto-rickshaw parking, Imphal East by observing all formalities.
