With reference to the subject matter mentioned above, I would like to bring to kind notice that the holy shrine of "Ima Tumkhong Lairembi" built atop the western side of Singda Dam which had been constructed at the expense of the villagers of Kadangband Part-I villagers had been a religious place of worship for the villagers of Kadangband Part-I since the establishment of the said village.

That, the Worship of the deity had been stalled for nearly two years now due to the on-going conflict between the Meitei and Kuki at present. The worship of the said holy deity mainly falls during the month of September-October every year. But, due the on-going conflict between the Meitei and Kuki, the Meitei villagers could not visit the holy shrine for security reason as the holy site falls under the jurisdiction of Kuki militants.

That, recently, as there has been a glimmer of peace being restored throughout the state, we were able to visit the holy site, but to our dismay the holy site had been burned down and vandalised by unknown individual(s). We could not, however ascertain the exact date and time of the act of vandalism carried out as we were not able to visit the holy place had been frequently patrolled by Kuki militants and as such we could not visit the holy site.
