Sir,

I have the honour to report today i.e. the 15th February, 2025 at about 9:00 p.m. received a reliable information about the presence of some extortionists at Khabeisoi, Imphal-East. Based on the said information, teams of CDO/IE led by myself, assisted by a column of 4 AR under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted a cordoned and searched operation.

In that, one suspected person was detained for verification and spot checking at Khabeisoi Maning Leikai. On verification, the detainee identified himself as one **Wangmayum Muktajudin @ Amuba, aged about 25 years, S/o Wangmayum Nasir of Khabeisoi Maning Leikai, Heingang PS, Imphal East District.** On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) joined through one Sanabam Amitkumar Singh of KCP (PWG) in the month of June, 2023 and presently working under his command. He further stated that, he got his basic military training for 15 days under the command of one Mr. Sadhu of KCP (PWG) group in the month of July, 2023. He further stated that he is involved in extortion of money from the general public, private firms, govt. Officials etc for raising their party fund.

So, the detainee was arrested from the spot i.e. Khabeisoi Maning Leikai, Imphal East District at 10:15 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
