Subject: - Report.



Sir,

I have the honour to state that today i.e. 21/02/2025 at about 07:30 am, a reliable information was received from our own source regarding the presence of some active cadres of KCP organisation in and around Achanbigei area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Inspector Kh. Pathou Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted cordon and search operation at Achanbigei Mayai Leikai. During that two unknown persons were seen standing at Achanbigei Mayai Leikai near Community Hall in a very suspicious manner. Due to their suspicious manner, they were detained at the spot for verification and checking.

During spot verification, they identified themselves as (i) Ningthoujam Yamba Singh (43 yrs) @ Boy @ Loijing @ Sanayamba S/o. (L) N. Deben Singh of Keirao Bitra Awang Leikai, Imphal East District and (ii) Usham Netaji Singh (35 yrs) @ Tonsana S/o. (L) U. Raghmani Singh of Tangkham Maning Leikai, Imphal East District.

During spot checking, the following articles were recovered from the possession of

1) Ningthoujam Yamba Singh: (i) one grey coloured side bag containing (a) one POCO M4 5G mobile handset along with one Airtel SIM card bearing mobile number 8132858768 (as disclosed by him) and (b) one Nokia mobile handset bearing IMEI No. 359574379993273/5 along with one Airtel SIM card bearing mobile number 8132067929 (as disclosed by him) and (ii) one brown wallet containing a sum of Rs. 30/- (Rupees thirty only) and one Aadhaar Card (recorded in his name) and

2) Usham Netaji Singh: (i) one Samsung Galaxy A34 5G mobile handset along with one Airtel SIM card bearing mobile number 9378147243 (as disclosed by him) and (ii) one dark brown wallet containing a sum of Rs. 4,200/- (Rupees four thousand two hundred only), one Driving Licence (recorded in his name) and one vehicle registration certificate card bearing registration number MN01AS 3652.

During preliminary verification, they disclosed that they are active members of KCP (MFL) organisation (who belong to G-5 organisation) and presently working under the command of s/s Commander namely Kh. Chinglai (Ph. No.7005586654) (Finance) of KCP (MFL) organisation (who also belongs to G-5 organisation) from Jiribam and under the instruction of their commander, they were involved in extortion activities by serving monetary demands/threats to Manipur Sand Union located at Koirengei and Sand sellers located in and around Imphal area particularly Koirengei, Sekmai, Irilbung and Patsoi side respectively.

They further disclosed that yesterday i.e., 20/02/2025, under the instruction of their commander, they went to Langjing side and served monetary demands/threats to sand sellers and also snatched keys and vehicle documents from some trucks carrying sand at Langjing area by using one Maruti Suzuki Swift Dzire Car white, in colour (owned by Usham Netaji Singh). As pointed out by Usham Netaji Singh, the above mentioned Maruti Suzuki Swift Dzire Car white in colour bearing registration number MN01AS 3652 was found parked near the above mentioned Community Hall and the said car along with its key was recovered from the spot at his instance.

Hence, Ningthoujam Yamba Singh and Usham Netaji Singh were arrested from the spot at 03:05 pm and 03:07 pm and the above recovered articles were seized at 03:10 pm and 03:12 pm respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
