Subject: - Report.

Sir,

I have the honour to state that today i.e. 25/03/2025 at about 01:38 pm, a reliable information was received regarding the presence of some active cadres of SOREPA (a faction of KYKL) organisation in and around Kongba area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room (OSCAR 1) at around 01:42 pm and conducted search operation at Kongba near Standard College area of Imphal East District. During that one unknown person was seen loitering at Kongba near Standard College in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Tayenjam Sanatomba Singh (43 yrs.) S/o. (L) T. Roton Singh of Chongtham Kona Mayai Leikai, Imphal West District a/p Kongba near Standard College.

On spot checking, the following articles were recovered from his possession:

- (1) One POCO C51 mobile handset along with one Airtel SIM card bearing mobile no. 6909585423 (as disclosed by him),
- (2) One POCO F1 mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 7085133354 and (b) 7085322095 (as disclosed by him) and
- (3) A sum of Rs. 1,010/- (rupees one thousand and ten only).

During preliminary verification, he disclosed that he is an active member of SOREPA (a faction of KYKL) organisation and he joined the said organisation in May, 2023 through one Rohit of SOREPA (a faction of KYKL) organisation who is presently staying at Kakching Khunou and he is presently working under the command of the above mentioned Rohit as his s/s Commander. On further verification, he disclosed that he received the above mentioned POCO C51 mobile handset from his commander at Kakching Khunou on 17/03/2025 to be used in their party activities and under the instruction of his commander, he served monetary demands/threats to various government officials in the name of Mangal of SOREPA (a faction of KYKL) organisation.

Hence, he was arrested from the spot at 02:02 pm and the above recovered articles were seized at 02:08 pm respectively by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
