I have the honour to report that today i.e. 05/04/2025 in between 3:00 pm to 3:30 pm my nephew namely Puyam Naresh Kumar (36) s/o P. Irabot of Kongba Makha Nandeibam Leikai Chongabi, IE was stabbed by a knife on his right abdomen by Puyam Ibobi @ Somo (56) s/o (L) P. Angou of Kongba Makha Nandeibam Leikai Chongabi, Imphal East District, Manipur at Kongba Makha Nandeibam Leikai Chongabi, IV-Road in front of the gate of the residence of the said Puyam Irabot of Kongba Makha Nandeibam Leikai Chongabi, Imphal East District, Manipur. As a result of which my nephew received serious injury on his person and evacuated into Advanced Specialty Hospital & Research Institute, Harikhagok Makhong, Thangapat Mapal, Palace Compound, Imphal East District, Manipur for medical treatment.

It is therefore, requested to kindly take necessary legal action against the said Puyam Ibobi @ Somo s/o (L) P. Angou of Kongba Makha Nandeibam Leikai Chongabi.
