Sir,

I have the honour to report that today i.e. the 7th April, 2025 at about 4:00 a.m. received a reliable information about the presence of some active members of the outlawed outfit PREPAK at Keirao Wangkhem Village of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 5/9 GR under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 5:30 a.m.

As a part of the operation, random frisking and checking to the suspected passersby. In that, one suspected person was detained for verification at Keirao Wangkhem Village near T.B. Hospital. On verification, the detainee identified himself as one **Thokchom Ningthem Meitei @ Lingjen (48 years) S/o Th. Kulandro Meitei of Pourabi Awang Leikai, Lamalai PS, Imphal East District. On checking his body, one mobile phone was found and recovered.** On further verification, the detainee stated that he is an active member of the outfit PREPAK joined in the year 2010 and got his basic military training in the same year at Myanmar with allotted army no. 3601187 of 36th batched. The detainee further stated that he is presently working under the command of one Mr. Ibomcha of PREPAK.

So, the detainee was arrested from the spot i.e. Keirao Wangkhem Village near T.B. Hospital, Imphal East District at 6:18 a.m. by observing due formalities. One mobile phone (ACE 2) bearing IMEI no. 359719580341420 & 359719580341438 along with one Airtel SIM card having mobile no. 8413855996 was seized from the possession of the arrestee at the spot i.e. Keirao Wangkhem Village near T.B. Hospital, Imphal East District at 6:25 a.m. by observing due formalities.

Therefore, the arrested person along with seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
