Subject : Report

Sir,

I have the honour to report that today i.e. the 7th April, 2025 at about 6:00 p.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outlawed outfit UPPK at Pebiya Pandit Leikai, Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 7:00 p.m.

As a part of the operation, random frisking and checking was conducted to the suspected passersby at Pebiya Pandit Leikai near Meira Shang. In that one scooter (Honda Activa) was detained for spot checking and verification. On checking, one mobile phone was found and recovered. On verification, the detainee identified himself as one **Ningombam Ajitkumar Singh @ Khagemba (49 years) S/o (Late) N. Chandramani Singh of Singjamei Makha Khongnang Pheidekpi, Singjamei PS, Imphal West District**. On further verification, the detainee stated that he joined the said outlawed outfit through one s/s – Deputy Finance Secy. Mr. Khumanlakpa of UPPK in the year 2011. He further stated that, he is presently holding the post of s/s – Project Officer of Imphal West District working under the command of the said Mr. Khumanlakpa of UPPK.

So, the detainee was arrested from spot i.e. Pebiya Pandit Leikai near Meira Shang, Imphal East District at 7:20 p.m. and seized one scooter (Honda Activa), grey in colour, bearing regd. no. MN-01N/1637 bearing Engine no. JF08E-8254970 and one mobile phone (Galaxy A05) bearing IMEI no. 350835032930625/01 & 351072882930625/01 along with one Jio SIM card bearing no. 89918650400125102857 from his possessions at the spot ie. Pebiya Pandit Leikai near Meira Shang, Imphal East District at 7:25 p.m. by observing due formalities. The arrestee is involved in the extortion of money from the general public, private schools and colleges located at Imphal areas.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
