

Sir,

I have the honour to report today i.e. the 8<sup>th</sup> February, 2025 at about 8:00 p.m. received a reliable information about the presence of some anti-social element suspected to be extortionists, illegal arms smuggler likely to carried out pre-judicial activities at Porompat, Imphal-East. Based on the said information, teams of CDO/IE Unit led by myself, under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)/Imphal East rushed to the said area and conducted a random frisking and checking to the suspected passers-by. During that, one suspected person was detained for verification and spot checking. On verification, the detainee identified himself as one **Khoisnam Roshan Singh @ Inao (27 years) S/o Kh. Hemanta Singh of Atoukhong Laiphprakpam, Lilong PS, Thoubal**. On checking his body, one mobile phone and one ID card was found and recovered. On further verification, it came to learnt that he is an illegal arm smuggler. He further stated that recently, he brought one pistol from an unknown person at the cost of Rs. 25, 000/- (twenty thousands) and sold to some unknown willing buyers. The arrestee is also directly involved in extortion activities from general public, govt. officials, shopkeepers etc.

In the light of the above facts and circumstances, the detainee was arrested from the spot i.e. Porompat DC Road, near Census Office, Imphal East at 9:00 p.m. by observing due formalities. One mobile phone (POCO - C50) bearing IMEI no. 868492069828168 & 868492069828176 along with one Airtel SIM card bearing no. 8991160990004944070U and one Voter Card were seized from his possession by observing due formalities from the spot i.e. Porompat DC Road, near Census Office, Imphal East at 9:10 p.m.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
