Today i.e 27th Jan.2025 at 9.15pm received an information that on the same day at around 9:00pm at CRESA Ground Bishnupur near FCI Godown where 7-A Side non Professional Night Football Tournament is going on, there was a confrontation between some spectators and unknown armed miscreants for the reason best known to them. Later public mob arised and the armed miscreants had fired 4/5 rounds few meters from the play ground and fled away taking advantages of darkness. As a result some spectators sustained injuries on their persons.


