Sir,

I am to report that today i.e. 04/02/2025, based on an input about the presence of some miscreants who are involved in extortion activities from Ningthoukhong area, a combined team of District Police Bishnupur led by P. Sanjoy Singh, MPS, DSP(CDO I)/BPR and Sub Shaktishen Singh, OC-CDO/BPR with a team of BPR PS led by OC-BPR/PS and C- Coy 8th Bn. CRPF under the supervision of Amarjit Singh, Lamabam, MPS, Addl. SP(Ops)/BPR and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur conducted Cordon Search Operation at Ningthoukhong ward no. 1 and 13 area from 6.30 am.

During the course of the operation 37 (thirty seven) houses were searched and 78 (seventy eight) persons were identified and that, one suspected individual was detained for verification. On spot verification, he identified himself as Pukhrambam Boini Singh Hopson (47) S/O (I) P. Birchandra Singh of Ningthoukhong ward no. 13 ITI road. On checking his mobile phones, some suspected documents and photos were detected. So, he was pick-up and brought at CDO Complex located at N Khunou and the operation was close at 7.30 am. On further verification, he disclosed that, he had joined RPI/PIA banned underground outfit in the year 1998 and got BMI (Basic Military Training) for six months at Myanmar and recently he had also collected/extorted a huge amount of money from general public, businessmen and government officials from Nambol, Bishnupur and Ningthoukhong area. He also collected an amount of Rs. 1,20,000/- (one lakh twenty thousand) in the month of September, 2024 for the said banned underground outfit. So, he was arrested at 8.10 am by observing proper formalities. From his possession, one POCO C50 smart phone with one Jio SIM card bearing mobile no. 8837474857, one OPPO A15s smart phone with one Jio SIM card bearing mobile no. 7005974429, one KICHADA mobile phone with one airtel SIM card bearing mobile no. 7629837762, one wallet black in colour containing, Rs. 320/- (three hundred and twenty) INR in cash, one PAN card, one Aadhaar card, one UCO bank debit card, one airtel payment bank card and one driving license were recovered and seized at 8.14 am.

The arrested persons along with the seized items are handed over to you for taking further necessary legal action.
