Subject: - Report.

Sir,

I have the honour to state that today i.e. 19/02/2025 at about 11:35 am, a reliable information was received from 165 TA and further corroborated from our own sources about the presence of some active cadres of KCP organisation in and around Akampat area of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Inspector Kh. Pathou Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted cordon and search operation at Akampat area. During that one unknown person was seen walking at Akampat near the NEILIT gate in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Kshetrimayum Badrajit Singh (39 yrs.) @ Yangba S/o. Ksh. Birjit Singh of Kongba Kshetri Leikai, Imphal East District. On spot checking, a sum of Rs. 100/- (rupees one hundred only) was recovered from his possession.

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organisation and joined the said organisation in August, 2023 through one Nonglen @ Bobby who is presently working as s/s Deputy Finance of KCP (PWG) organisation from Wangkhei (who is presently staying at Nepal). He further disclosed that he is also presently working under the command of the above mentioned s/s Commander Nonglen @ Bobby and under the instruction of his commander, he has been involved in extortion activities by serving monetary demands/threats to general public and collection of money from general public and he handed over the extorted money to his commander for their party fund. He also disclosed that he along with his associate namely Naokonba, an active cadre of KCP (PWG) organisation, is planning to attack at the residences of Hon'ble MLAs by using gun and hurling bomb.

Further, he disclosed that yesterday i.e., 18/02/2025, he along with his associate s/s Major Diamond of Finance Section of KCP (PWG) organisation from Moirang side extorted a sum of Rs. 2,00,000/- from government offices and today i.e., 19/02/2025, out of the said extorted amount of money i.e., Rs. 2,00,000/-, Major Diamond took Rs. 1,50,000/- for their party fund and out of the remaining amount of money i.e., Rs. 50,000/-, both he and Major Diamond got Rs. 25,000/- each for their personal use.

Hence, he was arrested from the spot at 02:10 pm and the above recovered article is seized at 02:14 pm by observing formalities.

Thus, the arrested person along with the seized article is handed over to you for taking further necessary legal action against him.
