Sir,

I have the honour to report that today i.e. 9<sup>th</sup> March, 2025 at about 11:30 a.m. received an information from a reliable source about presence of some cadres of the outlawed outfit PREPAK at Kongba Nandeibam Leikai, Imphal East District. Based on the said information, a combined team of CDO Imphal East Unit along with woman police personnel led by myself and a column of 4 AR, under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a search operation at Kongba Nandeibam Leikai, Imphal East District 12:10 p.m.

In that, one person was detained for verification and checking. On verification, the detainee identified himself as; **Chirom Rostam Meitei @ Chiromba (25 years) S/o Ch. Hemanta Meitei of Kongba Laihkuram Leirak, Irilbung PS, Imphal East District, Manipur** an active cadre of the outfit PREPAK (Pro). The detainee, stated that he joined the said organisation through one Mr. Abo of PREPAK (Pro) from Sagolband, Imphal West District in the month of January, 2025 and got his basic military training under the command of one Mr Punshiba of PREPAK (Pro) with allotted army no. 225HK3CH13 and presently working under his command.

So, the detainee was arrested from the spot i.e. **Kongba Nandeibam Leikai, Singjamei Road, opposite to Oil Pump, Imphal East District at 12:50 p.m.** by observing due formalities. One mobile phone (13C) bearing IMEI No. 866807072801724 & 866807072801732 along with one Airtel SIM Card bearing no. 8991160990026923544U were seized from his possession from the spot i.e. Khongba Nandeibam Leikai, Singjamei Road, opposite to Oil Pump, Imphal East District at 12:55 p.m. by observing due formalities.

On further verification, the arrestee stated that one of his associate cadre of their outfit is presently residing at his residence at Ucheckon. Immediately, our team along with the arrestee, rushed to Ucheckon and on the pointing of the arrestee one **Heikrujam Arvind Singh @ Micheal @ Heiroiba (32 years) S/o H. Shantikumar Singh of Ucheckon Jubraj Palli, Irilbung PS, Imphal East District, Manipur** was arrested from his residence i.e. Ucheckon Jubraj Palli, Irilbung PS, Imphal East District, Manipur at 1:10 p.m. by observing due formalities. One mobile phone (Redmi 9A) bearing IMEI No. 869973056258120 & 869973056258138 along with one Airtel SIM card bearing no. 8991160990024331906U from his possession at the spot i.e. Ucheckon Jubraj Palli, Irilbung PS, Imphal East District, Manipur at 1:15 p.m. by observing due formalities. On further verification of the detainees, both the detainees stated that they were involved in extortion of money from the general public for raising their party fund.

Thereafter, the arrested persons along with the seized mobile phones are being handed over to you for taking up further necessary legal procedures against them.
