Sub:- Report.

Sir,

I have the honour to report that today i.e. 10th March, 2025, at about 5:00 a.m. a reliable input was received about presence of some armed active member of the outlaw outfit UPPK (*United People's Party of Kangleipak*) in and around Ngariyan Hill ranges and accordingly, an operation was planned to capture the said member of the outfit. At about 5:40 a.m. a combined team of CDO Imphal East led by myself assisted by Jem. No. 834 Md. Amir Sultan of 1st MR/CDO/IE and Hav. No. 05006254 Th. Gyanizail Singh of 1st MR/CDO/IE Unit and a column of 5/9 GR under the command of Inspt. Kh. Henery Singh, Officer-in-Charge Commando Imphal-East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops) Imphal East District rushed to the said area and conducted a Counter Insurgency Operation. In that, one suspected person was detained for spot verification and checking. On checking the detainee bodies, 1 (one) .32 Pistol with magazine and 8 (eight) live rounds of .32 ammunitions were found and recovered.

On verification, the detainee identified himself as one **Ningombam Bonbon Singh @ Shamu (45 years) S/o N. Chaoba Singh of Bashikhong Bazar, Irilbung PS, Imphal East District, Manipur** an active member of the outlaw outfit UPPK. On further verification, the detainee stated that, he joined the outfit in year 2010 and got his basic military training in the same year for three months at Taka, Myanmar (Eastern Nagaland) under the command of one s/s - Sergeant Jangki of UPPK and presently working under the command of one s/s - Major Maibaton of UPPK. The detainee further stated that the above recovered pistol and ammunitions were handed over to him by one Mr. Tinko of UPPK. The detainee is also indulged in extortion of money from general public, private firms, govt. Officials etc. and transportation of arms and ammunitions.

In the above facts and circumstances, the detainees were arrested from the spot i.e. Keirao Wangkhem, Ngariyan Chingkhong near T.B. Hospital, Imphal East District, Manipur at **6:53 a.m.** by observing necessary formalities and seized; (i) one .32 Pistol marked as "**US No. 77057.65'**" with magazine and (ii) 8 (eight) nos. of .32 live ammunitions from the possession of the arrestee at 7:00a.m. at the spot by observing due formalities.

Thereafter, the arrested person along with the seized arms and ammunitions is being handed over to you for taking up further necessary legal procedures against him.
