That, My vehicle (Bolero BS6) white Colour Bearing registration No. MN01AW 6889, Engine No. TVN6K85150, Chassis No. MAX1XK2TVXN5L60511 which had been under the custody of Irilbung Police Station since 24<sup>th</sup> March 2023 was release on Zima in the name of Mr. Maningkambou Ringkaimai, Age 47 s/o Charaibou Ringkaima of Makui Naga senapati P.O T. waichong PS Saparmaina Kangpokpi District Mobile no. 8131070999 on 29/07/2024. The said Vehicles was Driven out by him along with Advocate Mr. Shokpei Woleng, Block C Tangkhul Avenue Chingmeirong Mobile No. 9862765416 Imphal East Manipur 795010 from the Police Station at around 03:00 pm.

Whereas, As soon as crossing the Police Station, A group of AT claiming themselves as Arambai Tenggol Irilbung Unit with Shophisticated weapon who received prior information before crossing the Police Station Waylaid/Hijacked my Vehicles and the incidence took place after driving out from the Police Station towards Porompat just around 5minute ago (not even a Kilometre passed) from the Police Station and those miscreant warned them not to disclosed their identity which may lead to heavy Conquencedes They ceased all the vehicles Original Document which are in my Name and driven away to their Arambai Tenggol Irilbung Unit Camp. The reason of delaying registration of FIR is that effort were made on my own capacity through various CSO and NGO proved Fruitless.

I therefore earnestly Request you to kindly take Appropriate action against those Perpetrator Arambai Tenggol Irilbung Unit and the Vehicles Safe and sound.
