As a result, both the drivers of the vehicle and one passenger of the diesel Auto got injured on their person and evacuated to Hospital for medical treatment and both the vehicles got badly damaged.

Hence, a regular suo-motu case has been registered under FIR No. 20(03) 2025 HNG-PS U/s 125(b)/281/324 (4)2023 BNS, for further investigation.

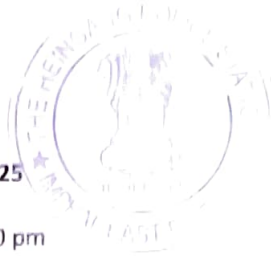
