Sir,

I have the honour to report today i.e. the 23rd March, 2025 at about 4:30 p.m. received a reliable information from 4 AR, FIU/4AR corroborated with our own intelligence about the presence of some extortionists at Mantripukhri, Imphal-East. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted searched operation at Mantripukhri Bazar and its surrounding areas of Imphal East District at about 5:15 p.m.

As a part of the operation, random frisking and checking was conducted to the suspected passersby at Mantripukhri bazar near Kalimai Mandir. In that one unknown suspected person coming from southern side was detained for spot verification and checking. On checking his body, two nos. of mobile phones and one wallet were found and recovered. On verification, the detainee identified himself as one **Md. Taj Khan @ Romen (37 years) S/o Md. Jalaluddin of Heibung Makhong Mayai Leikai, Mayang Imphal PS, Kakching District, A/p – Mantripukhri Friends Colony, Imphal East District** an active member of the outlaw outfit PREPAK (Pro) joined in the month of November, 2024. On further verification, the detainee stated that he had extorted money from various shops located in and around Mantripukhri Bazar, Imphal East District.

So, the detainee was arrested from the spot i.e. Mantripukhri Bazar near Kalimai Mandir, Imphal East District at 5:54 p.m. by observing all formalities and seized; (i) one mobile phone (vivo Y21G) bearing IMEI No. 861145063326012/00 & 861145063326004/00 along with two SIM cards bearing no. Vodafone 89910273214001050849GE and JIO 89918650400127960468, (ii) one mobile phone (JIO JBHARAT KW102) bearing IMEI No. 355297126008344 along with one JIO SIM card bearing no. 89918650400127922864 and (iii) one wallet containing a sum of Rs. 120/- (one hundred twenty rupees) and one AADHAR card from the spot i.e. Mantripukhri Bazar near Kalimai Mandir, Imphal East District at 6:00 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
