I am to state that today 28/03/2025 at about 4:15 pm 3(three) teams of special CDO, unit Khabeisoi, ~~with~~ ASI. K. Romen Singh and HC. L. Anil Singh led by Subedar L. Bebekananda Singh OC-SPL/CDO under the overall guidance of Dr. S. Ibomcha Singh, MPS, C.O. 6th IRB, In-Charge Special CDO unit, Khabeisoi conducted normal frisking and checking near Hundred Flower School, Pangei road. During the frisking and checking 1(one) unknown person was seen coming on foot on very suspicious manner towards Imphal. Due to his suspicious nature he was detained for verification on the spot. On verification he identified himself as Mr. Takhellambam Suresh Singh @ Athouba age about 23 years S/o T. Babu Singh of Keibi Khumuda, Imphal East Dist. Manipur – 795010. On his body searched, 1(one) carry bag (black in colour), inside the bag, 1(one) black T-Shirt, 1(one) olive green Cargo pant and 1(one) Aadhaar card bearing No. 6082 4125 5126.

On further verification, the detainee stated that he is an active cadre of banned organization of K.C.P. Polit Buro Statnding Committee (PSC). He joined in the year 2023, May and completed 15(fifteen) days Basic Training at Koutruk under the command of Pari. He was arrested near the Hundred Flower School at 5:52 pm and seized his belonging items at 5:55 pm.

So, I therefore handing over to you the arrested person and the seized items for taking up further necessary legal action against him.

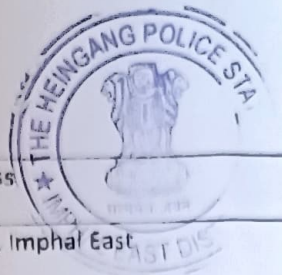
