Sir,

I have the honour to report that today i.e. the 28th March, 2025 at about 5:30 p.m. received a reliable information about the presence of some active members of the outlaw outfit KCP at Khundrakpam Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a searched operation at the said area at about 6:00 p.m.

As part of the searched operation random frisking and checking was conducted to suspected passersby. In that, one suspected person was detained for verification at Khundrakpam Awang Leikai, Imphal East District. On verification, the detainee identified himself as one Pukhrambam Rohit Singh @ Kakpa, aged about 21 years, S/o P. Inao Singh of Lamboi Khul Awang Leikai, Sagolmang PS, Imphal East District, an active member of the outlawed outfit KCP - PSC (Politburo Standing Committee) group.

On further verification, the detainee stated that he was recruited by one Mr. Athouba @ Thou of KCP (PSC) group and got his basic military training in the year 2024 with allotted army no. 216R under the command of one Mr. Ningthou of KCP (PSC) group presently holding the rank of s/s - Private of their outfit and working under the command of the said Mr. Pari of KCP (PSC) group. He further revealed that Mr. Athouba @ Thou has kept concealed one SMG Carbine in his possession.

So, the detainee was arrested from the spot i.e. Khundrakpam Awang Leikai, Imphal East District, Imphal East District at 6:21 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.

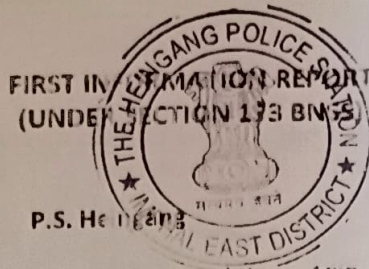
