Subject: - Report.



Sir,

I have the honour to state that today i.e. 15/04/2025 at about 02:05 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of SOREPA (a faction of KYKL) organisation in and around Waithou Chiru area under Irilibung PS with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted cordon and search operation at Waithou Chiru area. During that three unknown persons riding a Honda Dio scooter white and blue in colour was seen at Waithou Chiru near M/S Bujari Brick Field coming from Thiyam Konjin side and they along with the said Honda Dio scooter white and blue in colour bearing registration number MN01AF 7447 were detained at Waithou Chiru near M/S Bujari Brick Field for verification and checking.

During spot verification, they identified themselves as (i) Leishungbam Lenin Singh (31 yrs) @ Khuman S/o. L. Dhananjoy Singh of Andro Khuman Leikai, Imphal East District, (ii) Yumkhaibam Lukhoi Singh (32 yrs) @ Aboi S/o. (L) Y. Meipak Singh of Andro Khuman Leikai, Imphal East District and (iii) Sagolsem Dinesh Singh (25 yrs) S/o. S. Nodiachand Singh of Andro Khuman Laipat, Imphal East District (Driver of the Honda Dio Scooter). On spot checking the following articles were recovered from the possession of:

- 1) Leishungbam Lenin Singh: (i) one Redmi A3X mobile handset along with two Airtel SIM cards bearing mobile numbers (a) 9362651342 and (b) 9863544468 (as disclosed by him) and (ii) one Aadhaar card bearing no. 8849 2178 9254.
- 2) Yumkhaibam Lukhoi Singh: (i) one Redmi 7 mobile handset along with two Airtel SIM cards bearing mobile numbers (a) 7005980232 and (b) 8732873545 (as disclosed by him) and (ii) one black wallet containing a sum of Rs. 200/- (Rupees two hundred only) and one Aadhaar card bearing no. 7658 1607 1441.
- 3) Sagolsem Dinesh Singh: (i) one Redmi 13C 5G mobile handset along with two Jio SIM cards bearing mobile numbers (a) 7005869742 and (b) 9366466928 (as disclosed by him) and (ii) a sum of Rs. 10/- (Rupees ten only).

During preliminary verification, they disclosed that they are the active members of SOREPA (a faction of KYKL) organisation and they are presently working under the command of one s/s Commander Chingakham Korounganba @ Tomba from Andro Sanapat of SOREPA organisation. They further disclosed that today i.e., 15/04/2025, under the instruction of their s/s Commander Chingakham Korounganba, they served monetary demand/threat to a school located at Yairipok area and later on they came to Waithou Chiru area for serving monetary demand/threat by using the above mentioned Honda Dio scooter. Hence, as pointed out by Sagolsem Dinesh Singh, the above mentioned Honda Dio scooter white and blue in colour bearing registration number MN01AF 7447 along with its key was recovered at the spot at his instance.

Further, Leishungbam Lenin Singh disclosed that he is also presently working under the command of one s/s Chingakham Nanao @ Parihan from Andro Kharam Leikai of SOREPA organisation.

Hence, Leishungbam Lenin Singh, Yumkhaibam Lukhoi Singh and Sagolsem Dinesh Singh were arrested from the spot at 04:15 pm, 04:22 pm and 04:30 pm and the above recovered articles were seized at the spot at 04:41 pm, 04:44 pm and 04:47 pm by observing formalities.

Hence, the arrested persons and the above seized articles are handed over to you for taking further necessary legal action against them.
