I have the honour to report that yesterday i.e. 15/04/2025 at around 9:40 pm, while my husband namely Nongmaithem Romance Meitei aged about 32 yrs S/o Late N. Achoubi Meitei of Keirao Lairembi Leikai was returning home by riding his Hero Honda bearing regd No. MN06S 0096. On reaching Lairenpat near Pioneer Academy along Imphal Ngariyan Road, one unknown vehicle which was coming from the same direction was knocked down on the rear/back side of my husband's Hero Honda due to the rash or negligence driving on the part of the unknown driver and escaped from scene towards Irilbung side. As a result of which, my husband got multiple fracture on his body parts viz both legs, right arm and ribs. Immediately, he was evacuated to Advance Hospital, Palace Compound for medical treatment.
