I have the honour to report that today i.e. the 16th April, 2025 at about 9:00 a.m. received a reliable information about the presence of some active members of the outlawed outfit KCP at Kontha Ahallup village of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and 4 AR assisted by SI. Ch. Premjit Singh of CDO/IE Unit, Jem. Md. Mujibur Rahaman of 2nd IRB/CDO/IE, ASI. N. Ibotombi Singh of CDO/IE and Hav. No. 05006254 Th. Gyanizail Singh of 1st MR/CDO/IE under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops.)Imphal-East rushed to the said area and conducted a C.I. Ops. at the said area at about 10:10 a.m.

As a part of the operation, random frisking and checking was conducted to the suspected passersby. In that, one suspected person was detained for verification at the tri-junction of Lai Haraobam Leirak of Kontha Ahallup Makha Leikai, Imphal. On checking his body, one 9 mm Pistol loaded with six live rounds in the magazine and mobile phone was found and recovered. On verification, the detainee identified himself as one Wahengbam Ramananda Singh @ Rosou @ Luwangamba (50 years) S/o (Late) W. Biren Singh of Kontha Ahallup Makha Leikai, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (Lalumba) group joined through one Mr. Nando in the year 2008. He further stated that he is presently holding the post of s/s – General Secy. of Lalumba group working under the command of one s/s – President of KCP (Lalumba) Mr. Kshetrimayum Hitendra @ Kritibash @ Lalumba.

So, the detainee was arrested from the spot i.e. tri-junction of Laiharobam Leirak of Kontha Ahallup Makha Leikai, Imphal East at 11: 00 a.m. and seized; one 9 mm Pistol marked as 'SA538' loaded with six live rounds in the magazine and one mobile phone (Redmi 14 C 5G) bearing IMEI no. 869444076844125 & live rounds in the magazine and one mobile phone (Redmi 14 C 5G) bearing IMEI no. 869444076844125 & live rounds in the magazine and one mobile phone (Redmi 14 C 5G) bearing IMEI no. 869444076844125 & live rounds in the magazine and one Mirtel SIM card bearing no. 8991160990027008539U at 11:02 a.m. by observing due formalities.

On further verification, it came to learnt that he kept conceal two more pistols at the river bank of Imphal river which is opposite to his residence at Kongtha Ahallup Makha Leikai, Imphal East. Immediately, our team along with the arrestee rushed to the said place and on the instance and pointing of the arrestee, two nos. of .32 pistols with two magazines and eight live rounds were found and recovered. The recovered; (i) One .32 Pistol marked as '3796 Made in Italy' loaded with three live rounds in the magazine and (ii) one..32 Pistol marked as '0791 Russia' loaded with five live rounds in the magazine were seized from the spot i.e. river bank of Imphal river at Kontha Ahallup Makha Leikai, Imphal East District opposite to the residence of the arrestee (Wahengbam Ramananda Singh) at 11:10 a.m. by observing due formalities.

Therefore, the arrested person along with seized arms, ammunitions and mobile phone is being handed over to you for taking up further necessary legal actions against him.
