Subject: - Report.

Sir,

I have the honour to state that today, i.e. 18/04/2025 at about 05:05 am, a reliable information was received from our own source and further corroborated from the information input provided by ARFIU and 33-AR regarding the presence of some active cadres of PREPAK(Pro) organisation (a faction of PREPAK organisation) in and around Kyamgei area under Irilbung PS of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Kyamgei Heibong Makhong area. During that one unknown person was seen loitering at Kyamgei Heibong Makhong near KYPC Community Hall in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Thangjam Henary Meitei (31 yrs) @ Wanglen s/o Th. Inao Singh of Kyamgei Mayai Leikai, Imphal East District.

On spot checking, a sum of Rs. 130/- (Rupees one hundred and thirty only) was recovered from his possession.

During preliminary verification, he disclosed that he is an active cadre of PREPAK(Pro) organisation (a faction of PREPAK organisation) and he joined PREPAK organisation in December, 2008 and got Basic Military Training at Rakhine, Myanmar in the year 2009 and was allotted Army No. 37855 and he is presently holding the rank of s/s Lance Corporal of PREPAK(Pro) organisation and he is presently working under the command of one s/s Lieutenant Colonel Ishingchaoba @ Naobi of PREPAK(Pro) organisation from Uripok since November, 2024. He further disclosed that under the instruction of his commander s/s Lieutenant Colonel Ishingchaoba @ Naobi, he is involved in extortion activities by serving monetary demand to general public located in and around Imphal area.

Hence, he was arrested from the spot at 05:40 am and the above recovered article was seized at the spot at 05:47 am by observing formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
