Sir,

Kindly referred to the reference no. 19/SDPO-PRT/2025/152; dated: 4<sup>th</sup> March, 2025. I the undersigned have the honour to submit the enquiry report as follows:-

The brief of the complaint is that; the complainant namely, Naoshekpam Rakesh Singh (34 yrs) S/O Naoshekpam Santikumar Singh of Bamon Kampu Makha Leikai report to OC-IBG/PS on 3/03/2025 stating that he is working as a head mistry of Iron house Construction. In the month of January, 2025 when he engaged at Loklaobung, Tera, Khangbok for construction of iron house, some unknown persons who identified themselves as underground numbering about 5/6 came at his house ¾ times in a four wheeler vehicle and last came in a Bolero and enquired him. They threatened his family members to contact with one Lion through mobile no. 6909788294 otherwise dire consequences will be faced. However, he couldn't contact because of fear and reported to OC-IBG/PS for taking action against the unknown persons. Hence, the report and it refers to GD Entry no. 11/IBG-PS/2025; dated : 03/03/2025.

In the course of enquiry, examined the complainant minutely and carefully who fully corroborated with the report made by him (complainant). The complainant stated that he runs a business "Hingminashi Enterprises" which work in the construction of iron and steel houses since 2021. And many investors invested their money into his business which he returned through monthly tenure with profit. But due to the eruption of Meitei-Kuki conflict he couldn't returned the money to his investors timely. Since, the month of January, some unknown persons numbering about 5/6 identified themselves as underground came to his house in a white bolero car 4/5 times searching him. They gave the above phone. No. 6909788294 to his family member and instructed to contact one individual Mr. Lion. The unknown persons also threaten his (complainant) family that they would kill him if he fails to contact and meet them. On checking the given mobile no. through True Caller, it shows Upk and the complainant suspected that the individuals may be members of UPPK organization.

In further course of enquiry, visited the residence of the complainant and examined his family members and they also stated the same version as stated by the complainant that 5/6 unknown individuals have repeatedly came at their residence searching the complainant whom they identified themselves as underground, but didn't disclosed their organization name. Also the family members could identify the regd no. of the white Bolero Vehicle as MN01X 6564 on checking their CCTV camera installed at their premises. Further checked the CCTV camera installed at the premises of the complainant and found that the individuals had came at their residence multiple times.

From the enquiry, the report made by the complainant is genuine and prima facie case is established to conduct investigation under relevant section of law.
