Subject: - Report.

Sir,

I have the honour to state that today, i.e. 24/04/2025 at about 06:15 am, a reliable information was received from our own source and further corroborated from the information input provided by 33-AR regarding the presence of some active cadres of KCP (PWG) organisation (a faction of KCP organisation) in and around Thiyam Konjin area under Irilibung PS of Imphal East District with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Thiyam Konjin area covering Chekshabi Pat. While checking a farm house located at Chekshabi Pat, one unknown person was found in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Takhellambam Premkumar Singh (47 yrs) @ Inao @ Budha S/o. (L) T. Khogen Singh of Thiyam Konjin Samanching Leikai, Imphal East District.

On spot checking, (1) three mobile handsets i.e., (i) one realme C12 mobile handset along with two SIM cards: (a) one Airtel SIM card bearing mobile no. 8732050956 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 8787718153 (as disclosed by him), (ii) one Nokia model no. TA-1575 mobile handset without SIM card and (iii) one itel MAGIC X Pro mobile handset along with one Jio SIM card bearing mobile no. 8794713388 (as disclosed by him) and (2) one brown wallet containing one Aadhaar card bearing no. 6948 4895 8758 was recovered from his possession.

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organisation (a faction of KCP organisation) and under the instructions of two Commanders i.e., one s/s Commander Chingkei from Kiyamgei and one s/s Commander Kiran of KCP (PWG) organisation, he is involved in extortion activities by threatening general public and money borrowers to recover lended money located in and around Imphal area in the name of KCP (PWG) organisation and he also got commission for being involved in the above mentioned extortion activities related to recovery of lended money from the borrowers.

On checking the said farm house, one Maruti Alto car silver in colour bearing registration no. MN01K 6515 (used by him) was also recovered from the said farm house at his instance.

Hence, he was arrested from the spot at 07:16 am and the above recovered article was seized at the spot at 07:24 am by observing formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
