Today i.e., 20/02/2025 at 09.00 pm, received an information from the Control Room, SP/Imphal West District, Manipur that on the same day at around 08.45 pm, one Honda Dio, White in colour, bearing Regn No. MN01V-1183 was knocked down by one Casper without registration number at Sagolband Thangapat Mapal in front of Wizard Printers coming from Wahengbam Leikai side due to rash and negligent driving on the part of the Casper driver and after commission of the crime, the said Casper fled away from the spot. As a result of which the rider of the Honda Dio received seriously injured on his person and immediately evacuated to RIMS Hospital for medical treatment. And the scooter was also badly damaged.
