Subject: - Report.

Sir,

With due respect, I have the honour to report that today i.e. 22/02/2025 at around 09:30 pm, received information from private source that one individual will be sending some contrabands items suspected to be Ganja by post at General Post Office, Head Office, Imphal. The source report was reduced in writing at 09:35 pm and submitted a copy to OC-Imphal PS. Thereafter under the supervision of OC-Imphal PS, I along with a police team of Imphal PS rushed immediately at General Post Office, Imphal to intercept the drug trafficker.

On arrival, the said individual was pointed out by the private source while he was standing with two carton boxes wrapped with white plastic bags inside the Parcel Hub, General post office and he was detained immediately for verification after informing to the Post Master of the office. He identified himself as Md. Wahidur Rahaman (22) yrs s/o Md. Tamijur Rahaman of Keibung Mathak Leikai, PO/PS-Thoubal, Thoubal District, Manipur. I took his option of search in which he accepted to conduct search without any presence of Gazetted Officer. However, in presence of Gazetted officer namely N. Ingocha Singh, MPS, SDPO-Imphal and one post master namely, Lukram Radheshyam Singh (58) yrs s/o (L) L. Gourachand Singh of Thoubal Ningombam Thongju Leikai checked the two carton boxes, 16(sixteen) numbers of plastic packets (i.e. 11 nos. packets in the box marked as 'A' and 5 nos. of packets in the box marked as 'B') of suspected to have contraband Ganja was found inside the carton boxes. The recovered 16 plastic packets suspected to have contraband Ganja was properly weighed by using a weighing machine in presence of Gazetted officer and independent witness. The 16 (sixteen) numbers of plastic packets suspected to have contraband Ganja is 17.808 kg including the weight of the plastic approximately without the weight of the carton boxes. The recovered item is listed under the ND & PS Act. So, the recovered 16 (sixteen) numbers of plastic packets suspected to have contraband Ganja, one mobile I-phone I-14 Model red in colour having phone number 9233126239 bearing JIO SIM Card No. 89918650400118624149, one mobile phone SAMSUNG A54 light blue in colour having phone no. 8118923567 bearing AIRTEL SIM Card No. 8991160990024314361U and Rs.30,000 (Rupee thirty thousand) of 60 nos. of Rs.500 denominations were seized on production by Md. Wahidur Rahaman (22) yrs s/o Md. Tamijur Rahaman of Keibung Mathak Leikai, Thoubal in presence of one independent witness namely Lukram Radheshyam Singh (58) yrs s/o (L) L. Gourachand Singh of Thoubal Ningombam Thongju Leikai by preparing a weighing and seizure memo at 10:50 pm and he was arrested on the spot at 10:55 pm. Further, the seized carton boxes containing suspected to be contraband ganja was wrapped with the white plastic bag and covered with plastic tap and also taken signature of the accused and the witnesses. So, the arrested person along with the seized items are handed over to you for further necessary action.
