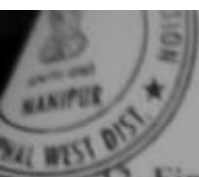

## 12. First Information contents:

One Khwairakpam Ramananda Singh, aged about 43 years, S/o Khwairakpam Nandashyam Singh, permanent resident of Ningthoukhong Ward No.7, presently residing at Kwakeithel Leimakhujam Leikai, P.O. & P.S. Imphal, District-Imphal West, Manipur reported with OC/IPS stating that as per the agreement date 01.07.2021 executed between the Global Solutions, Bidg. No.1010, First Floor, HBC, Sector-62, Faridabad-121004 (Haryana), and him, he has provided his motor car Scorpio (Silver Colour) as Taxi to the consultant, namely, Dr. Ngangbam Robinchandra Singh, for GHS (Global Solutions) (Project), at Imphal. The full description of his SCORPIO which has been provided as taxi to Imphal Consultant of GHS Project, herein below respectively: SCORPIO, Model Body Type-Hard Top, Regd. No. MN01G5231, Chassis No. MA1TA4SJXG2A13388 and Engine No. SJG4A10576. The aforesaid agreement was from 01.07.2021 and 31.12.2021, and rent for hiring the said motor car is Rs.50,000/- (Rupees Fifty Thousand only), for running up-to 2500 KM in a calendar month, plus Rs.12/- (Rupees Twelve only) per KM as extra in excess of 2500 KM in a calendar month. Thereafter, the aforesaid agreement has been continuing till date by mutual understanding between the Global Solutions and him. Thereafter, the aforesaid agreement has been extending time to time, and it is still continuing till date by mutual understanding between the Global Solutions and him. Recently, he went to insurance company to renew insurance of his said motor car which was end on 09-11-2023 and the staff of the insurance company asked to submit a photograph of his said motor car. In order to take a photograph, to renew his said motor car (Scorpio) insurance, he asked Dr. Ngangbam Robinchandra Singh, S/o (L) Ng. Meghachandra Singh of Chingamathak Nameirakpam Leikai, IW about the matter, however, the said Dr. Ngangbam Robinchandra Singh avoid one or other reason from taking the photograph of his said motor car (Scorpio), and having no option, he contacted the driver of Dr. Ngangbam Robinchandra Singh, namely Salam Gunachandra Singh, S/o Salam Nimai Singh, resident of Langthabal, P.O. - Canchipur, P.S. - Singjamei, District Imphal West, Manipur. Quite surprise to him, the driver Salam Gunachandra informed him that his said motor car was mortgaged to some unknown person 2/3 months back. When he enquired about his matter to Dr. Ngangbam Robinchandra Singh and he told him that he had mortgaged his said motor car (Scorpio) to one person from Thambalkhunou and asked for some days to return his said motor car (Scorpio), but he failed to give his said motor car. Hence, the written report.
