Sir,

I have the honour to state that today i.e. 08/03/2025 at about 01:30 pm a reliable information was received from 33 AR and further corroborated from our own sources about the presence of some active cadres of NRFM organisation in and around Dewlahland area of Imphal East District under Imphal Police Station with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri M. Amit Singh, Addl. SP(Ops.)IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Dewlahland area. During that one unknown person was seen walking near the gate of Christian Hospital, Dewlahland in a very suspicious manner. Due to his suspicious manner, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Lamabam Bidyasagar Singh (22 yrs) @ Ibungo @ Leingakpa S/o. L. Tompok Meitei of Ngaikhong Khullen Mayai Leikai, Ward No. 3, Bishnupur District.

On spot checking, one POCO mobile handset along with one Jio SIM card bearing mobile number 9366896471 (as disclosed by him) was recovered from his possession.

During preliminary verification, he disclosed that he is an active cadre of NRFM organisation and joined the said organisation in the year December, 2024 and got Basic Military Training for forty days at Yainganpokpi area and presently working under the command of one s/s Corporal Khuman (Ph. No. 8118921625) of NRFM organisation and presently staying at Myanmar.

Hence, he was arrested from the spot at 02:00 pm and the above recovered articles were seized at 02:05 pm respectively by observing formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
