Sub:- Report

Sir,

I have the honor to report that on 13/03/2025 at about 11:05 AM, based on a reliable input provided by 33 AR and corroborated with our own source about the movement of armed militants in Imphal Area. A combined teams of CDO-BPR including myself, Hav. Kh. Kunje Singh, HC W. Sanathoi Singh along with CDO-IW and a team of Imphal-PS including women Police constable under the command of Shri P. Sanjoy Singh, MPS, DSP CDO-I/BPR and Sub. Y. Shaktishen Singh, OC/CDO-BPR under the close supervision of Shri Amarjit Singh Lamabam, MPS, ASP(Ops)-BPR and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-BPR conducted an extensive cordon and search operation at Sagolband Sayang Kurao Makhong, Imphal West, Manipur and it was started at around 1:30 pm.

During the search operation, one lady was detained at her residence on suspicion and later identified herself as Thokchom Ongbi Anita Devi aged about 46 years w/o (L) Thokchom MR Singh of Sagolband Sayang Kurao Makhong, Imphal West. She was examined thoroughly and on examination she disclosed herself as an active cadre of PLA, presently working under the command of one Moirangthem Oken @ Somorjit @ Lamyamba s/o M. Ibocha Singh of Khurai Kongpal, an active cadre of PLA. On further house search of her residence, the following incriminating articles were recovered on production by Thokchom Ongbi Anita Devi aged about 46 years w/o (L) Thokchom MR Singh. On the seeing the police team the local women folks numbering about 30/40 started gathering with an intention to create public mob. Immediately our teams left the spot with the woman and the recovered items for Imphal Police Station. Later the recovered items were seized and arrested her at Imphal Police Station by observing formalities at 02:15 pm and 02:30 pm respectively.

Particulars of the seized items: -

2. 18 (eighteen) nos. of 9mm live rounds.
3. 15(fifteen) nos. of .38 live rounds.
4. Rs 5000 (500\*10=5000).




