13. First Information contents: Today i.e, 14/03/2025 A combined team comprising of Churachandpur

District Police, including Sangaikot PS, 36 AR, NAB-CCP and DFO-CCP launched destruction of illegal Poppy cultivation in Dampi Hill Range(Dahkhul,Tuilelong stream) of Sangaikot Sub-Division, Churachandpur under the supervisor of Shri.Thanglien Gangte MPS,DSP-CCP.

During the operation the combined team visited various areas in the said areas but the poppy plants found in the areas are all withered and seems to have been already harvested .Some poppy plants remnants which are found standing were destroyed.The total area of illegal Poppy destruction is estimated to be 1(one) Acres (approx.) which is estimated to be worth Rs.30,000(Thirty thousands)in local market.During the operation no arrest was made as no cultivators were found and the land owner could not be identified. However, some dry pods of poppy plants were seized from the area of destruction after observing proper formality.

Thanglien Gangte, MPS, DSP-CCP.

During the operation The combine team visited Various areas in the said areas but , the poppy plants found in the areas are all withered and seems to have been already harvested. Some poppy plants remnants which are found standing were destroyed. The total areas of poppy destruction is estimated to be 1(one) Acre(Appx), which is estimated to be worth Rs.30,000(Thirty Thousands) in Local market. No arrest were made as No cultivator were found and the land owner could not be identified. However, 10(ten) pots of dry poppy plants were sized from the areas of destruction after observing proper formalities. The seized article and other necessary document are submitted herewith for further necessary action.



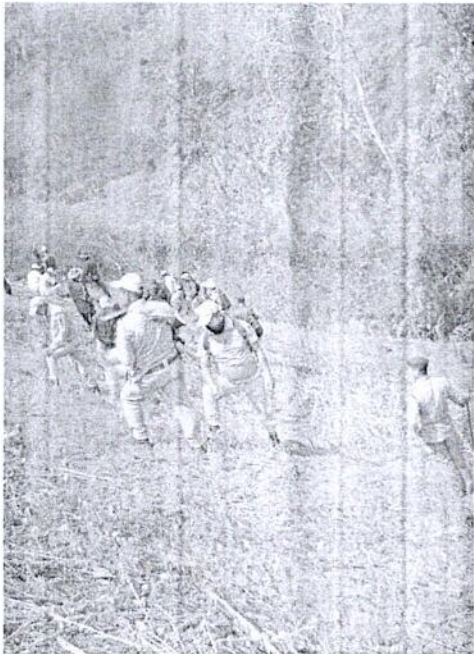
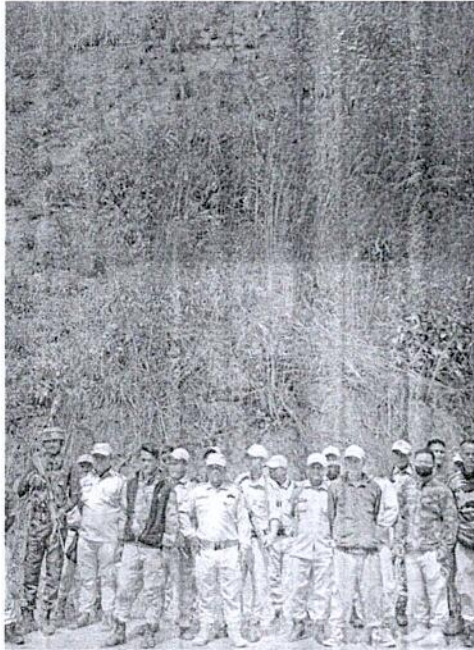
