On 02/12/2024, I was issued one INSAS Rifle butt folding bearing Regd No.18272881 alongwith two magazines and 40 (forty) rounds of INSAS ammunitions by Arm Kote Incharge, Churachandpur Police Station. I recieved the said arms alongwith its ammunitions by appending my signature on the arms issue register. I usually carried my issued service weapon while on duty and after duty I kept back in safe custody in my trunk box in my shared room with my colleague.

On 18th February, 2025 at around 09:30 PM, after performing my duty I kept my service INSAS Rifle butt folding bearing Regd No.18272881 alongwith two magazines and 40 (Fourty) rounds of INSAS ammunitions inside my trunk box at our Barrack located inside Churachandpur Police Station campus. However, It has came to light that, on 04th March, 2025, my INSAS Rifle butt folding bearing Regd No. 18272881 alongwith one magazine which contains 20 (twenty) rounds of INSAS ammunitions was found missing from my trunk box and could not be trace till date. C/No. Thanggoulen Chongloi who were also my roommates to help me in finding my missing rifle. All others except Mr. Thanggoulen Chongloi co-operate to my request. However, PC Thanggoulen Chongloi did not pay any heed to my request by making many excuses. I engaged source person(s) to monitor the movement and behaviour of my roommates but till date no evidence to recover my missing rifle or identity of the suspected person(s) could not be provided to me. However, I highly suspected that the theft was committed by my roommates as no other civillians enter our barrack without our permission.
