Sub : Complaint for abduction of my husband.

Sir,

With all due regards, I would like to state that at around 3.30 am this morning i.e. 11th Feb., 2025, at my residence in Uripok Yambem Leikai, a group of 30 armed persons barged into my house and forcibly abducted my husband Shri Yambem Laba at gunpoint out from his bed. He was wearing his vest and was barefoot. No reason was provided for such a horrendous action and his whereabouts are still not available.

A similar incident has happened before when a group of armed persons came and forcibly made him apologise on record for a Facebook Post he uploaded.

In another incident. In September 2024, the same residence at Uripok Yambem Leikai was attacked with gunshots. Both the above cases were reported at your Police Station.

The sequence of events met out on our family has created a huge fear Psychosis to me and my immediate family members.

Kindly initiate immediate action to trace his whereabouts and requesting the police Dept. to bring my husband safe and sound.
