Dear Sir/Madam,

I, the undersigned, a member of the Zomi community, respectfully submit this formal complaint to the esteemed Officer In Charge of Churachandpur District Police Station regarding a distressing incident that has deeply hurt and insulted the sentiments of the Zomi people.

It has come to our attention that volunteers of Hmar Students' Association, Tuithaphai Joint Headquarters, with malicious intent, desecrated the Zomi community flag, which is an important cultural symbol representing the unity, identity, and heritage of the Zomi people. The flag holds profound significance for us and is an integral part of our community's self-recognition and pride. To disrespect this symbol is not only an affront to the Zomi people but also a clear act of communal disrespect and cultural intolerance.

The desecration of our community flag took place on 17 March, 2025 at around 4:00 PM near Sielmat Bridge, Zenhang Lamka, and it has been reportedly recorded on mobile phones and uploaded on various social media channels (Photocopy of the screenshot (s) of the video is enclosed as Annexure). The actions of these volunteers are not only provocative, but also anger our community. We consider this act to be a deliberate and targeted attack on the Zomi culture and heritage, and it has the potential to incite social unrest, violence, and division within our society if left unaddressed. The act of the volunteers of the Hmar Students' Association, Tuithaphai Joint Headquarters has also attracted the provision of section 196 of BNS (Bharatiya Nyaya Sanhita) read with section 3 (5) of the BNS, which their act in itself is a deliberate commission which is prejudicial to the maintenance of harmony between different communities of the district.

As per the laws of our country, deliberate acts of vandalism, defacement, and desecration of cultural symbols are criminal offenses that need to be investigated and punished to the full extent of the law. It is clear that the intention of the acts of these volunteers is to cause disharmony and promote enmity towards the Zomi Community in the minds of the common people and all the volunteers

have caused such acts to be perpetrated and assembled at the place of incident with common intention. I hereby request that a First Information Report (FIR) be filed in this regard, and that the police take immediate and comprehensive action to identify the individuals responsible for this act. Further, I urge the police to ensure that these culprits are brought to justice and held accountable for their unlawful and provocative actions.

In addition to the investigation, I kindly request that you take necessary steps to ensure the safety and security of the Zomi community in the district. Such incidents of desecration not only harm the cultural and emotional well-being of the Zomi people but also create unnecessary tensions that can escalate into larger societal problems.

I trust that the Churachandpur District Police Station will give this matter the urgent and serious attention it deserves, in line with its duty to maintain law and order, and protect the cultural rights and dignity of every community within its jurisdiction.




