Respected Sir,

I the undersigned being the wife of the deceased namely Lalropui aged about 51 yrs s/o L Thasawt presently residing at Sinate Colony, Sielmat village who was murdered with precision by unidentified Zomi supporters. The incident took place at Hebron veng, Sielmat village at around 10:45 PM would like to present facts and circumstances for your information and necessary legal actions.

That, armed rioters who are identified as Zomi supporters (shouting Zogam slogan) gathered around sielmat area create ruckus and attacked those volunteers who assisted in enforcing curfew imposed by the district magistrate, churachandpur at around 9 pm on 18th of March 2025 with the sole intention to raise and hoist Zomi Flag at building situated at sielmat vilage churachandpur manipur.

Tha attackers were armed with sophisticated air guns with mounted scope/lens for accuracy, sling, stones, wooden rods, iron rods other sharp weapons and deliberately attacked and targeted my husband who was volunteered in enforcing curfew imposed by the district magistrate as the village authority of Sielmat village is duty bound to assist the District Administration in maiantaining law and order in the town. The injury mark in the chest suggests that the he was shot in the chest and the airgun pellet which caused his death is still believed to be inside his

body. He was rushed to Sielmat Hospital where he succumbed to his injury and was pronounced death.

The violent mob also caused damaged to public and private property and created an atmosphere of fear and chaos in the area. They have not spared even hospitals and even hospitals and patients and pelted stones which creates fear psychosis among the citizen of India.

I the undersigned being the wife of the deceased namely Lalropui aged about 51 years S/O L Thasawt presently residing at Sinate Colony, Sielmat Village who was murdered with precision by unidentified Zomi Supporters. The incident took place at Hebron Veng, Silemat Village at around 10:45 PM would like to present facts and circumstances for your information and necessary legal actions.

That, armed rioters who are identified as Zomi supporters (Shouting Zogam slogan) gathered around Silemat Area create ruckus and attacked those volunteers who assisted in enforcing curfew imposed by the District Magistrate, Churachandpur at around 09:00PM on 18th of March, 2025 with the sole intention to raise and hoist Zomi Flag at building situated at Sielmat Village, Churachandpur, Manipur.

The attackers were armed with sophisticated air guns with mounted scope/lens for accuracy, sling, stones, wooden rods, iron rods other sharp weapons and deliberately attacked and targeted my husband who was volunteered in enforcing curfew imposed by the District Magistrate as the Village Authority of Sielmat Village is duty bound to assist the District Administration in maintaining law and order in the

town. The injury mark in the chest suggests that he was shot in the chest and the airgun pellet which caused his death is still believed to be inside his body. He was rushed to Sielmat Hospital where he succumbed to his injury and was pronounced death.

The violent mob also caused damaged to public and private property and created an atmosphere of fear and chaos in the area. They have not spared even hospitals and patients and pelted stones which create fear psychosis among the citizen of India

It is therefore requested that an FIR be registered immediately and take necessary legal actions against the culprits in the interest of justice.

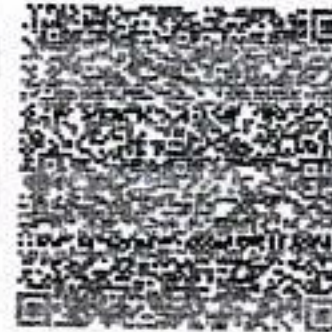

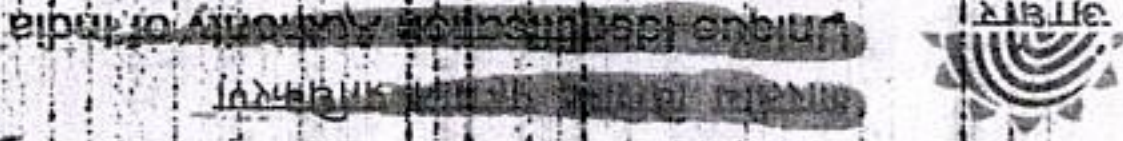
