1. That, I am a permanent resident of Nehru Marg wherein several communities have been living peacefully in the past without any hatred and disturbances from any quarter. However, on 16/03/2025 due to an incident that occurred at the neighbouring locality between some people, a shocking and an unexpected misunderstanding arises in communal lines which creates tension between two certain communities, and our locality (Nehru Marg) happens to be a place where the two communities are residing together. Fortunately, due to the swift action taken by Local Committes, Secrity forces, Tribe Leaders, no unwanted incident happened and the situation returned back to normal.
2. That, while we are under the impression that everything was under control, on 18-03-2025 at about 11:00 PM a large number of an unruly mob came up from Rengkai side towards Nehru Marg chanting 'KUKI-HMAR, KUKI-HMAR...' and started pelting stones which caused damaged to our window panes about 7 (seven in Numbers), thereby compelling myself and my family members

to take shelter elsewhere. (Copies of the photographs of the damaged window panes are enclosed herewith for easy reference. Our window panes vandalized are worth about 4,00,000/- (Rupees four lakhs only).

Therefore, in such a situation, I have no other option but to report the matter to your esteem office to thoroughly investigate the matter and take proper and appropriate legal action against the said culprits for their mischief and inappropriate destruction of our properties.

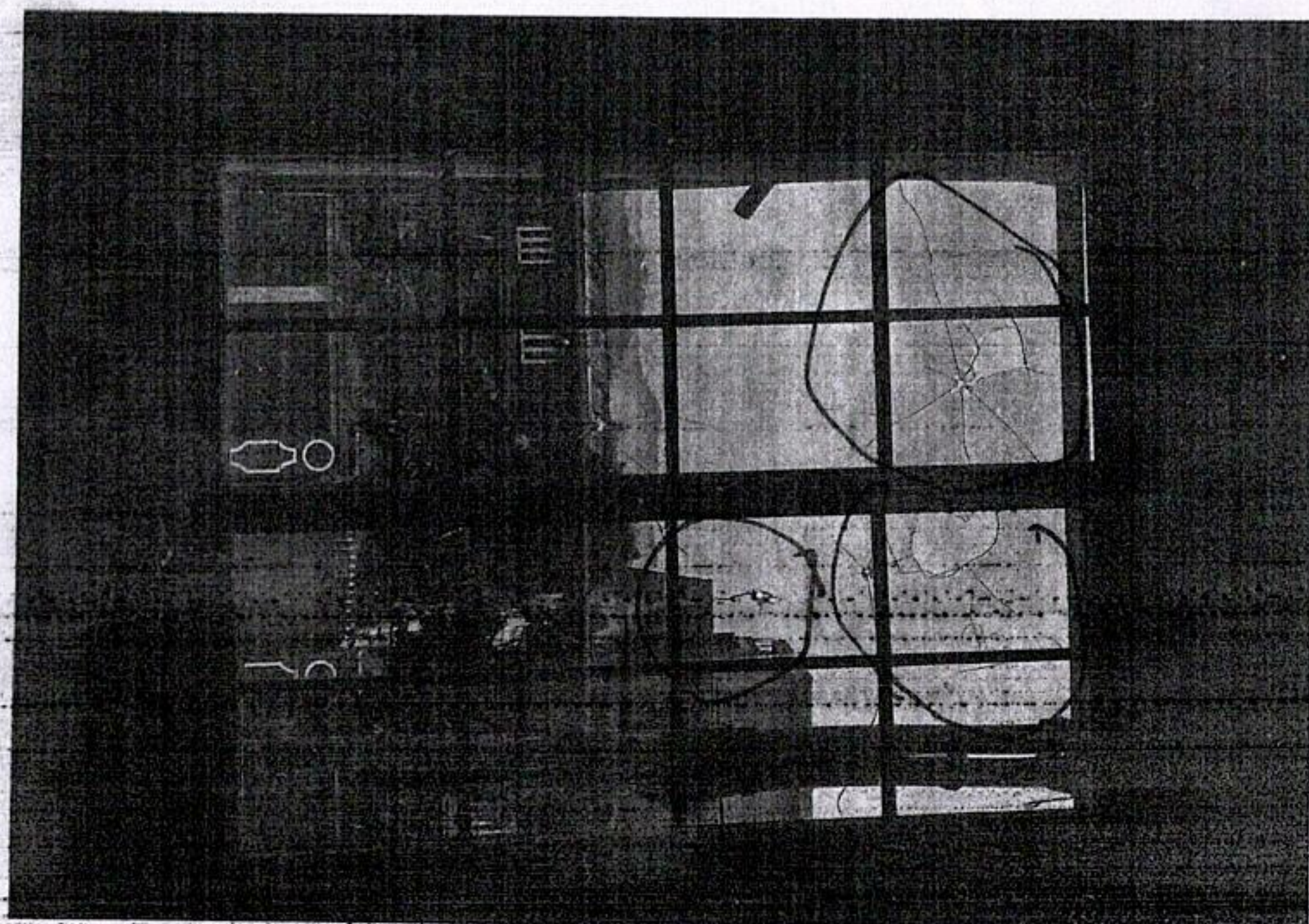
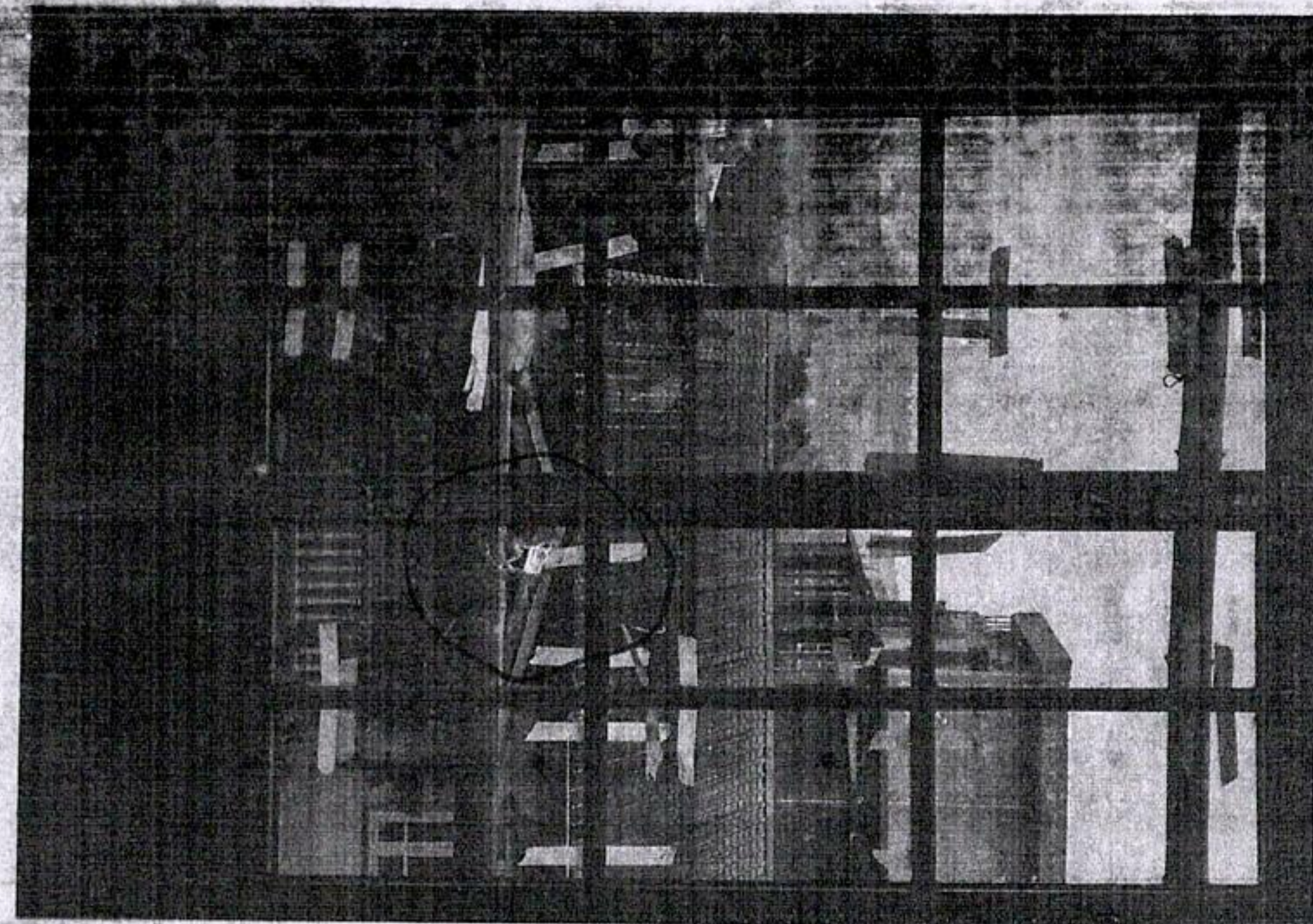
