During the attack, the assailants vandalized and destroyed two vehicles parked at the premises:

Additionally, the miscreants pelted stones at the relief centre, shattering numerous window glasses and causing significant damage to the property. Their violent actions resulted in severe trauma and fear among the innocent camp inmates, who were already in a vulnerable state. The attackers also issued threats to the IDPs, further worsening the distress of those taking shelter at the centre. This incident has created a serious law and order situation, requiring immediate intervention.

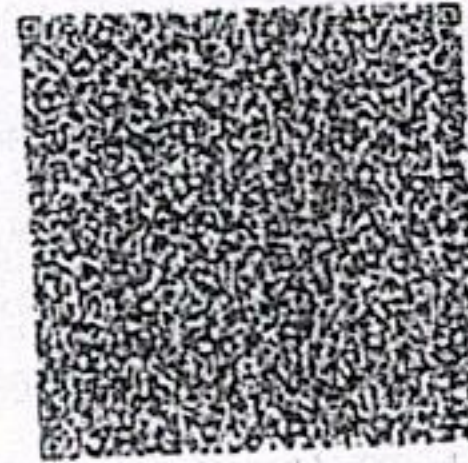

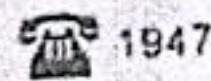
