Sub: To Lodge an FIR against Mr Mangtin Thang Haokip

Sir,

- Based on input from 1/2 FID , 3 CIB, regarding presence of Mangtin Thang Haokip, the Fin Secy UKNA, a non SoO Gp, at M Songgel village, Churachandpur, a column under Nb Sub Damar Bahadur Sunar ex 36 AR, alongwith team of 1/2 FID, 3 CIB was launched from HQ Veng on 22 Mar 2025 at 2130h. The team laid a cordon to apprehend the suspected individual, who was being continuously tracked by own sources.
- When own team moved in to apprehend the person on a pre-designated signal, the suspected person attempted to flee using cover of darkness, seeing the fleeing suspect, own team reacted swiftly & communicated the location of the suspect to the cordon team, which successfully apprehended the suspect. However, Nb Sub Damar Bahadur Sunar successfully surrounded him, forcing him to surrender without any exchange of fire on 22 Mar 2025 at 2330h at 2350h. The suspected person was kept in custody of 36 Assam Rifles at Quarter Guard during the preliminary investigations.
- The suspected person Mr Mangtin Thang Haokip, the Fin Secy , UKNA, Age 35 years, Khengjang Village, district- churachandpur was handed over to the police team on 23 Mar 2025 at 1730 hrs at CCPur PS with a Medical & NOC certificate duly signed by suspect, police & 36 Assam Rifles & is produced as Appx 'A'. The suspect is to be produced before the Hon'ble Magistrate, Churachandpur (Manipur) for due legal action.
- The investigation revealed the following :-
  - The suspect was involved in illegal & anti- national activities to include extortion, kidnapping, weapon smuggling & drug trafficking on behalf of UKNA which are a threat to national security.
  - On ivestigation, individual has accepted that he is the finance secy of UKNA a non SoO gp.
  - On investigation about mobile phones carried by the suspect, it is revealed that he is part of an organized crime syndicate operational in several areas of churachandpur district (Manipur). Furthermore, such syndicate are felicitating high extortion, thus troubling the general populace. Several contacts, photos, whatsapp chats, conversation messages were seen in the mobile phone of the suspect attached as Appx 'B'



5. It is clear from the above investigation, that the suspect is heavily involved in several anti-national activities, thus challenging the writ of the state, rule of law & national security & integrity & recommended to be charged under appropriate sections of IPC.
